A BILL FOR AN ACT

To further amend Public Law No. 8-93, as amended by Public Laws Nos. 8-98, 8-123, 8-137 and 9-020, by further amending section 1, as amended by Public Law No. 8-98, for the purpose of specifying the apportionment of the funds appropriated, and by further amending section 2, as amended by Public Laws Nos. 8-98, 8-123, 8-137 and 9-020, for the purpose of designating the allottee of said funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 8-93, as amended by Public Law  
2 No. 8-98, is hereby further amended to read as follows:

3 "Section 1. The sum of \$1,300,000, or so much thereof as may be  
4 necessary, is hereby appropriated from the General Fund of the  
5 Federated States of Micronesia for the fiscal year ending  
6 September 30, 1995, for school needs throughout the Federated  
7 States of Micronesia. The funds appropriated under this act  
8 shall be apportioned as follows:

23 Section 2. Section 2 of Public Law No. 8-93, as amended by Public  
 24 Laws Nos. 8-98, 8-123, 8-137 and 9-020, is hereby further amended to read  
 25 as follows:

1 "Section 2. All funds appropriated by this act shall be  
2 allotted, managed, administered, and accounted for in  
3 accordance with applicable law, including, but not limited  
4 to, the Financial Management Act of 1979. The allottee of  
5 the funds appropriated under subsection (1)(a)(i), (1)(a)(ii)  
6 and (1)(a)(iii) of section 1 of this act shall be the  
7 Tolensom Authority. The allottee of the funds appropriated  
8 under subsection (1)(b) of section 1 of this act shall be the  
9 Northern Namoneas Development Authority. The allottee of the  
10 funds appropriated under subsection (1)(c) of section 1 of  
11 this act shall be the Southern Namoneas Authority. The  
12 allottee of the funds appropriated under subsections  
13 (1)(d)(i) and (1)(d)(ii) of section 1 of this act shall be  
14 the Pattiw Development Authority. The allottee of the funds  
15 appropriated under subsection (1)(e)(xiii) of section 1 of  
16 this act shall be the Lower Mortlocks Development Authority.  
17 The allottee of the funds appropriated under subsection (4)  
18 of section 1 of this act shall be the Governor of the State  
19 of Yap or his designee. The allottee of all other funds  
20 appropriated by this act shall be the President of the  
21 Federated States of Micronesia or the President's designee.  
22 The allottees shall be responsible for ensuring that these  
23 funds, or so much thereof as may be necessary, are used  
24 solely for the purposes specified in this act, and that no  
25 obligations are incurred in excess of the sum appropriated.

1 The authority of the allottees to obligate funds appropriated  
2 by this act shall not lapse."

3 Section 3. This act shall become law upon approval by the  
4 President of the Federated States of Micronesia or upon its becoming law  
5 without such approval.
