

A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended by Public Laws Nos. 9-104, 9-129 and 9-137, by further amending section 5, as amended by Public Law No. 9-104 and renumbered by Public Law No. 9-137, for the purpose of changing the allottee of funds for public projects in Pohnpei, Kosrae and Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 9-100, as amended by Public Law  
2 No. 9-104 and renumbered by Public Law No. 9-137, is hereby further amended  
3 to read as follows:

4 "Section 5. All funds appropriated by this act shall be allotted,  
5 managed, administered, and accounted for in accordance with  
6 applicable law, including, but not limited to the Financial  
7 Management Act of 1979. The allottee of the funds appropriated  
8 under subsection (1) of section 1 of this act shall be the Governor  
9 of the State of Chuuk. The allottee of the funds appropriated  
10 under subsection (2)(a), (2)(b), (2)(c) and (2)(d) of section 1 of  
11 this act shall be the Toleisom Authority. The allottee of the funds  
12 appropriated under subsection (2)(e) and (2)(f) of section 1 of  
13 this act shall be the Mayors of the respective municipalities. The  
14 allottee of the funds appropriated under subsection (2)(g), (2)(h)  
15 and (2)(i) of section 1 of this act shall be the Mayor of Polle  
16 Municipality. The allottee of the funds appropriated under  
17 subsection (3) of section 1 of this act shall be the Southern  
18 Namoneas Development Authority. The allottee of the funds  
19 appropriated under subsection (4) and (8) of section 1 of this  
20 act shall be the Northern Namoneas Development Authority. The  
21 allottee of the funds appropriated under subsection (5) of section  
22 1 of this act shall be the Mortlock Development Authority. ~~The~~  
23 ~~allottee of the funds appropriated under subsection (6)~~  
24 ~~of section 1 of this act shall be the Pattiw Development~~  
25 ~~Authority.~~ The allottee of the funds appropriated under

1 subsection (6)(a) of section 1 of this act shall be the Halls Project  
2 Coordinator. The allottee of the funds appropriated under  
3 subsection (6)(b) of section 1 of this act shall be the Weito  
4 Project Coordinator. The allottee of the funds appropriated under  
5 subsections (6)(c) and (6)(d) of section 1 of this act shall be the  
6 Pattiw Project Coordinator. The allottee of the funds  
7 appropriated under subsection (6)(e) of section 1 of this act shall  
8 be the Northwest Islands Project Coordinator. The allottee of the  
9 funds appropriated under subsection (7) of section 1 and  
10 subsection (2) of section 4 of this act shall be the Speaker of the  
11 Congress of the Federated States of Micronesia or the Speaker's  
12 designee. The allottee of the funds appropriated under subsection  
13 (2) of section 2 of this act shall be the Chairman of the Kosrae  
14 Utilities Authority, and the allottee of the funds appropriated  
15 under subsection (9) of section 2 of this act shall be the Governor  
16 of the State of Kosrae. The allottee of the funds appropriated  
17 under subsection (2)(a) and (2)(b) of section 3 of this act shall  
18 be the Pohnpei Visitor's Bureau. The allottee of the funds  
19 appropriated under subsection (1) and (3) of section 4 of this  
20 act shall be the Governor of the State of Yap. The allottee of all  
21 other funds appropriated by this act shall be the President of the  
22 Federated States of Micronesia or the President's designee. The  
23 allottees shall be responsible for ensuring that these funds, or so  
24 much thereof as may be necessary, are used solely for the  
25 purpose specified in this act, and that no obligations are incurred

1 in excess of the sum appropriated. The allottee of the funds  
 2 appropriated under subsection (1)(b) of section 3 of this act shall  
 3 not obligate any funds appropriated therein without first  
 4 consulting with the members of the Pohnpei Delegation to  
 5 Congress. The authority of the allottees to obligate funds  
 6 appropriated by this act shall not lapse."

7 Section 2. This act shall become law upon approval by the President of  
 8 the Federated States of Micronesia or upon its becoming law without such  
 9 approval.
