
A BILL FOR AN ACT

To further amend Public Law No. 9-095, by further amending section 5, as amended and renumbered by Public Law No. 9-103, for the purpose of changing the allottee of funds for the Northwest Islands schools, and for other purposes.

BE IT ENACTED BY THE PEOPLE OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 9-095, as renumbered by Public Law
2 No. 9-103, is hereby further amended to read as follows:
3 "Section 5. All funds appropriated by this act shall be allotted,
4 managed, administered, and accounted for in accordance with
5 applicable law, including but not limited to the Financial Management
6 Act of 1979. The allottee of the funds appropriated under
7 subsection (1) of section 1 of this act shall be the Board of the
8 Saramen Chuuk Academy. The allottee of the funds appropriated
9 under subsection (2) of section 1 of this act shall be the Toleisom
10 Authority. The allottee of the funds appropriated under subsection
11 (3) of section 1 of this act shall be the Southern Namoneas
12 Development Authority. The allottee of the funds appropriated under
13 subsection (4) of section 1 of this act shall be the Northern
14 Namoneas Development Authority. The allottee of the funds
15 appropriated under subsection (5) of section 1 of this act shall be
16 the Mortlocks Development Authority. The allottee of the funds
17 appropriated under subsection (6) of section 1 of this act shall be
18 ~~The Plan Development Authority~~ Northwest Islands Project
19 Coordinator. The allottee of the funds appropriated under section 3
20 of this act shall be the Governor of the State of Yap. The allottee of
21 the funds appropriated under subsection 3 of section 4 of this act
22 shall be the Kosrae State Scholarship Board. The allottee of all other
23 funds appropriated by this act shall be the President of the
24 Federated States of Micronesia or the President's designee. The
25 allottees shall be responsible for ensuring that these funds, or so

1 much thereof as may be necessary, are used solely for the purpose
 2 specified in this act, that no obligations are incurred in excess of the
 3 sum appropriated, and that no obligations are incurred until after
 4 consultation between the Congressional Delegation and the allottees.
 5 The authority of the allottees to obligate funds appropriated by this
 6 act shall not lapse."

7 Section 2. This act shall become law upon approval by the President of the
 8 Federated States of Micronesia or upon its becoming law without such approval.
