

A BILL FOR AN ACT

To further amend Public Law No. 8-100, as amended by Public Laws Nos. 8-121, 9-011, 9-024, 9-028 and 9-115, by further amending section 6, as amended by Public Laws Nos. 8-121 and 9-028, for the purpose of changing an allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 8-100, as amended
2 by Public Laws Nos. 8-121 and 9-028, is hereby further
3 amended to read as follows:

4 "Section 6. All funds appropriated by this act shall
5 be allotted, managed, administered and accounted for
6 in accordance with applicable law, including, but
7 not limited to, the Financial Management Act of
8 1979. The allottee of the funds appropriated under
9 subsections (1), (6), (7), (8), and (9) of section 1
10 of this act shall be the Secretary of Education.

11 The allottee of the funds appropriated under
12 subsection (2) of section 1 of this act shall be the
13 Lower Mortlocks Development Authority. The allottee
14 of the funds appropriated by subsection (3) of
15 section 1 of this act shall be the Northern Namoneas
16 Development Authority. The allottee of the funds
17 appropriated under subsection (4) of section 1 of
18 this act shall be the Southern Namoneas Development
19 Authority. The allottee of the funds appropriated
20 by subsection (5) of section 1 of this act shall be
21 the Northwest Islands Project Coordinator ~~Patikiw~~
22 ~~Development Authority~~. The allottee of the funds
23 appropriated under section 2 of this act shall be
24 the Governor of the State of Kosrae. The allottee of
25 the funds appropriated under subsections (1), (3),

1 and (4) of section 4 of this act shall be the
 2 Governor of the State of Yap. The allottee of the
 3 funds appropriated under subsection (2) of section 4
 4 of this act shall be the President of the College of
 5 Micronesia-FSM. The allottee of all other funds
 6 appropriated by this act shall be the President of
 7 the Federated States of Micronesia or the
 8 President's designee. The allottees shall be
 9 responsible for ensuring that these funds, or so
 10 much thereof as may be necessary, are used solely
 11 for the purpose specified in this act, and that no
 12 obligations are incurred in excess of the sum
 13 appropriated. The authority of the allottees to
 14 obligate funds appropriated by this act shall not
 15 lapse."

16 Section 2. This act shall become law upon approval by
 17 the President of the Federated States of Micronesia or upon its
 18 becoming law without such approval.
