A BILL FOR AN ACT

To further amend Public Law No. 8-100, as amended by Public Laws Nos. 8-121, 9-011, 9-024, 9-028 and 9-115, by further amending section 6, as amended by Public Laws Nos. 8-121 and 9-028, for the purpose of changing an allottee of funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 6 of Public Law No. 8-100, as amended 1

by Public Laws Nos. 8-121 and 9-028, is hereby further

"Section 6. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsections (1), (6), (7), (8), and (9) of section 1 of this act shall be the Secretary of Education. The allottee of the funds appropriated under subsection (2) of section 1 of this act shall be the Lower Mortlocks Development Authority. The allottee of the funds appropriated by subsection (3) of section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under subsection (4) of section 1 of this act shall be the Southern Namoneas Development Authority. The allottee of the funds appropriated by subsection (5) of section 1 of this act shall be the Northwest Islands Project Coordinator Partitiv Derkellophedit//Authotiky. The allottee of the funds appropriated under section 2 of this act shall be the Governor of the State of Kosrae. The allottee of the funds appropriated under subsections (1), (3),

and (4) of section 4 of this act shall be the . 1 Governor of the State of Yap. The allottee of the 2 funds appropriated under subsection (2) of section 4 3 of this act shall be the President of the College of Micronesia-FSM. The allottee of all other funds 5 appropriated by this act shall be the President of the Federated States of Micronesia or the President's designee. The allottees shall be 8 responsible for ensuring that these funds, or so 9 much thereof as may be necessary, are used solely 10 for the purpose specified in this act, and that no 11 obligations are incurred in excess of the sum 12 appropriated. The authority of the allottees to 13 obligate funds appropriated by this act shall not 14 15 lapse." Section 2. This act shall become law upon approval by 16 17 the President of the Federated States of Micronesia or upon its 18 becoming law without such approval.
