AN ACT

To further amend title 24 of the Code of the Federated States of Micronesia (Annotated), as amended, by amending section 920 thereof, to allow for proper implementation of NORMA administrative penalties, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 920 of title 24 of the Code of the 1 2 Federated States of Micronesia (Annotated), as amended, is 3 hereby amended to read as follows: "Section 920. Penalties for other violations of this 4 subtitle. 5 (1) Any person who commits an act in violation of 6 any provision of this subtitle, for which no civil 7 penalty is otherwise specified in this chapter or the R preceding chapters, shall be subject to a civil 9 penalty of not more than \$100,000." 10 11 12 13 14 15 16 17
