CONGRESSIONAL BILL NO. 20-144, C.D.1

AN ACT

To further amend Public Law No. 20-60, as amended by Public Law No. 20-65, by amending sections 3, 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 20-60, as amended by
2 Public Law No. 20-65, is hereby further amended to read as

11 Section 3. Section 6 of Public Law No. 20-60, as amended by
 12 Public Law No. 20-65, is hereby further amended to read as
 13 follows:

14 "Section 6. Allotment and management of funds and lapse
 15 date. All funds appropriated by this act shall be
 16 allotted, managed, administered and accounted for in
 17 accordance with applicable laws, including, but not
 18 limited to, the Financial Management Act of 1979. The
 19 allottee shall be responsible for ensuring that these
 20 funds, or so much thereof as may be necessary, are used
 21 solely for the purpose specified in this act, and that
 22 no obligations are incurred in excess of the sum
 23 appropriated. The allottee of funds appropriated under
 24 section 2 of this act shall be the Governor of Yap State
 25 or his designee. The allottee of the funds appropriated

1 under sections 3 and 4 of this act shall be the
2 President of the Federated States of Micronesia or his
3 designee; PROVIDED THAT the allottee of funds
4 appropriated under subsections 3(a) to 3(o) of this act
5 shall be the Mayor of Lelu Town Government or his
6 designee; the allottee of funds appropriated under
7 subsections 3(p) to 3(ae) of this act shall be the Mayor
8 of Tafunsak Municipal Government or his designee; the
9 allottee of funds appropriated under subsections
10 4(2)(e), 4(2)(g) and 4(2)(m) of this act shall be the
11 Pohnpei Transportation Authority (PTA); the allottee of
12 funds appropriated under subsection 4(2)(o) of this act
13 shall be the Pohnpei Utility Corporation (PUC). The
14 allottee of the funds appropriated under subsections
15 5(1), 5(3) and 6(6) of this act shall be the Governor of
16 Chuuk State or his designee; the allottee of the funds
17 appropriated under subsection 5(2) of this act shall be
18 the Mortlocks Island Development Authority (MIDA); the
19 allottee of the funds appropriated under subsection 5(4)
20 of this act shall be the Southern Namoneas Development
21 Authority; the allottee of the funds appropriated under
22 subsection 5(5) of this act shall be the Faichuk
23 Development Authority. The authority of the allottee to
24 obligate funds appropriated by this act shall lapse on
25 September 30, 2020."

PUBLIC LAW No. 20-75

1 Section 4. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
