

CONGRESSIONAL BILL NO. 20-190, C.D.1

AN ACT

To further amend Public Law No. 20-60, as amended by Public Laws Nos. 20-65 and 20-75 by amending sections 3 and 5 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs in the states of Kosrae and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
