Dear Speaker Simina:

I am pleased to transmit the following congressional act, which I have signed to become Public Law No. 20-141:

Congressional Act No. 20-138, entitled: "AN ACT TO APPROPRIATE THE SUM OF \$14,000,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30. 2019, FOR THE PURPOSE OF FUNDING PRIORITY INFRASTRUCTURE PROJECTS AND OTHER PROJECTS PROGRAMS IN THE STATES OF YAP, KOSRAE, POHNPEI AND CHUUK, AND FOR OTHER PURPOSES."

I appreciate the attempt by Congress in giving a breakdown for this public project appropriation. Based on the analysis by Budget, most of the funding (about 80%) was allocated to infrastructure; whereas, the rest were economic development, social programs, education, government services environment and health. The largest part of infrastructure, 38%, went to road projects, 37% to land acquisition and other unspecified priority projects. Small portions went to maritime, water, communication, energy and education. Budget further advised that this appropriation has 144 total projects. In my view, this new set of projects could create serious administrative issues because there are ongoing projects funded by Congress that are not closed out up to now. Yet, there are no adequate provisions in this act to address the increase cost of implementation.

Finally, I urge Congress to consider the imminent impacts that this significant appropriation will have upon the anticipated revenue shortfall come 2023. With less money available for appropriation, Congress needs to be aware that financial restraint becomes important. Thank you.

AN ACT

To appropriate the sum of \$14,000,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2019, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.
