CONGRESSIONAL BILL NO. 20-263, C.D.1,
C.D.2, C.D.3, C.D.4, C.D.5

AN ACT

To further amend Public Law No. 20-141, by amending the title, sections 1, 2, 3, 4 and 5 thereof, to deappropriate the sum of \$1,200,000 and change the use of funds previously appropriated therein, for the purpose of funding priority infrastructure projects and other projects and programs in the states of Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The title of Public Law No. 20-141 is hereby
2 amended to read as follows:

3 “To appropriate the sum of \$12,800,000 from the General Fund
4 of the Federated States of Micronesia for the fiscal year ending
5 September 30, 2019, for the purpose of funding priority
6 infrastructure projects and other projects and programs in the
7 states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes”

8 Section 2. Section 1 of Public Law No. 20-141 is hereby
9 amended to read as follows:

10 “Section 1. The sum of \$12,800,000, or so much thereof as may
11 be necessary, is hereby appropriated from the General Fund of
12 the Federated States of Micronesia for the fiscal year ending
13 September 30, 2019, for the purpose of funding priority
14 infrastructure projects and other projects and programs in the
15 states of Yap, Kosrae, Pohnpei and Chuuk. The funds appropriated
16 under this section shall be apportioned as follows:

17 Section 3. Section 2 of Public Law No. 20-141 is hereby
18 amended to read as follows:


