A BILL FOR AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 6, as amended by Public Laws Nos. 5-99, 5-126, 6-47, 6-78, 7-56, and 7-131, to modify the use of funds appropriated therein for Chuuk State public projects, and by further amending section 8, as amended by Public Laws Nos. 5-99, 7-2, 7-56, 8-62, and 9-034 to change the allottee of funds for section 8, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 6 of Public Law No. 5-89, as amended by Public Laws
2	Nos. 5-99, 5-126, 6-47, 6-78, 7-56, and 7-131, is hereby further amended to
3	read as follows:
4	"Section 6. Halls, Western Islands and Namonwitto public projects.
5	The sum of \$200,000, or so much thereof as may be necessary, is
6	hereby appropriated from the General Fund of the Federated States of
7	Micronesia for the fiscal year ending September 30, 1989, for the

5	Laws Nos. 5-99, 7-2, 7-56, 8-62, and 9-034 is hereby further amended to

7	"Section 8. Allotment and management of funds and lapse
8	date. All funds appropriated by this act shall be allotted,
9	managed, administered, and accounted for in accordance with
10	applicable law, including, but not limited to, the Financial
11	Management Act of 1979. The allottee of the funds
12	appropriated under sections 1, 2 and 3 of this act shall be
13	the Governor of Chuuk State, except for the funds
14	appropriated by sub-paragraph (1)(d) of section 1 for which
15	the allottee shall be the Chuuk State Congressional
16	Delegation; by sub-paragraph (2) of section 1 for which the
17	allottee shall be the Executive Director of the Chuuk
18	Maritime Authority; and by sub-paragraph (3) of section 1 for
19	which the allottee shall be the Executive Director of the
20	Chuuk Organization of Community Action. The allottee of the
21	funds appropriated under sub-paragraph (11) of section 2 of
22	this act shall be the Northern Namoneas Development
23	Authority. The allottee of the funds appropriated under
24	sections 4 and 7 of this act and under subsections (5) and
25	(6) of section 5 of this act, and under subsections

(4)(a)(i), (4)(b)(i), (4)(c)(i) and (4)(d)(i) of section 6 of this act shall be the Chairman of the Chuuk State Congressional Delegation. The allottee of all other funds appropriated under section 5 of this act shall be the Lower Mortlocks Development Authority. The allottee of the funds appropriated under sub-paragraph (1) and subsections (4)(a)(ii), (4)(b)(ii), (4)(c)(ii), (4)(d)(ii) and (4)(e) of section 6 of this act shall be the Hall Islands Development Authority. The allottee of the funds appropriated under subparagraphs (2) and (5) of section 6 of this act shall be the Wdito Valata Davalopment **\times Nomunweito Project The allottee of the funds appropriated under Coordinator. sub-paragraphs (3) and (6) of section 6 of this act shall be the Pattiw Islands Development Authority. The allottee of the funds appropriated under sub-paragraph (7) of section 6 of this act shall be the Board of Directors of the Nomwin Coop. Each allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purposes specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottees to obligate funds appropriated by this act shall not lapse *** experited."
