A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by adding a new subchapter X to chapter 6 for the purpose of establishing a new Aquaculture Revolving Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Title 55 of the Code of the Federated States
- 2 of Micronesia, as amended, is hereby further amended by the
- 3 addition of a new subchapter X of chapter 6 entitled
- 4 "Aquaculture Revolving Fund".
- 5 Section 2. Title 55 of the Code of the Federated States
- of Micronesia, as amended, is hereby further amended by the
- 7 addition of a new section 655 of subchapter X of chapter 6 to
- 8 read as follows:
- 9 "Section 655. <u>Establishment</u>. There is hereby
- 10 created and established the Aquaculture Revolving
- 11 Fund, referred to in this subchapter as the 'Fund',
- separate from the General Fund of the Federated
- 13 States of Micronesia and all other funds."
- Section 3. Title 55 of the Code of the Federated States
- of Micronesia, as amended, is hereby further amended by the
- 16 addition of a new section 656 of subchapter X of chapter 6 to
- 17 read as follows:
- "Section 656. <u>Purpose</u>. The purpose of the Fund is
- 19 to permit revenues from the operations of the FSM
- 20 Aquaculture Center, referred to in this subchapter as
- the 'Center', to be used for the expenses of the
- 22 Center."
- Section 4. Title 55 of the Code of the Federated States
- 24 of Micronesia, as amended, is hereby further amended by the
- 25 addition of a new section 657 of subchapter X of chapter 6 to

14	of Micronesia or his designee in accordance with the
15	provisions of this title and any other applicable
16	laws."
17	Section 6. Title 55 of the Code of the Federated States
18	of Micronesia, as amended, is hereby further amended by the
19	addition of a new section 659 of subchapter X of chapter 6 to
20	read as follows:
21	"Section 659. Annual Report. The President or his
22	designee shall report to the Congress of the
23	Federated States of Micronesia on the status of the
24	Fund at the close of each fiscal year."
