

TENTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

THIRD REGULAR SESSION, 1998

CONGRESSIONAL BILL NO. 10-266, C.D.1, C.D.2, C.D.3

AN ACT

To appropriate the sum of \$1,985,162 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of meeting the needs of primary and secondary public schools and State hospitals and State-administered public health programs and funding social and economic projects or grants throughout the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$935,162, or so much thereof as may be			
2	necessary, is hereby appropriated from the General Fund of the			
3	Federated States of Micronesia for the fiscal year ending September			
4	30, 1999, for the purpose of meeting the needs of primary and			
5	secondary public schools and State hospitals and State-administered			
6	public health programs and funding social and economic projects or			
7	grants in the State of Chuuk. The funds appropriated herein shall			
8	be apportioned as follows:			
9	(1) Election District No. 1 \$ 150,000			
10	(2) Election District No. 2			
11	(3) Election District No. 3			
12	(4) Election District No. 4			
13	(a) Faichuk Community Health Center 66,000			
14	(b) Other projects			
15	(5) Election District No. 5			
16	(6) Chuuk State Hospital (no funds may be			
17	used for salaries, travel, training, or vehicles) 40,000			
18	(7) Chuukese students at COM-FSM Pohnpei			
19	campus 10,000			
20	(8) Xavier High School			
21	(a) Replacement of restroom(s) 21,850			
22	(b) Kitchen upgrading 17,739

3	Section 2. The sum of \$600,000, or so much thereof as may be		
4	necessary, is hereby appropriated from the General Fund of the		
5	Federated States of Micronesia for the fiscal year ending September		
6	30, 1999, for the purpose of meeting the needs of primary and		
7	secondary public schools and State hospitals and State administered		
8	public health programs in the State of Pohnpei. The funds		
9	appropriated by this section shall be disbursed and used for		
10	educational, hospital and public health purposes, excluding any		
11	disbursement for salaries, travel, training, or vehicles. The funds		
12	appropriated under this section shall be apportioned as follows:		
13	(1) Election District No. 1 \$ 200,000		
14	(2) Election District No. 2 200,000		
15	(3) Election District No. 3 200,000		
16	Section 3. The sum of \$300,000, or so much thereof as may be		
17	necessary, is hereby appropriated from the General Fund of the		
18	Federated States of Micronesia for the fiscal year ending September		
19	30, 1999, for the purpose of meeting the needs of primary and		
20	secondary public schools and State hospitals and State-administered		
21	public health programs in the State of Yap. The funds appropriated		
22	under this section shall be disbursed and used for educational,		
23	hospital and public health purposes, excluding any disbursement for		
24	salaries, travel or vehicles. The funds appropriated herein shall		
25	be apportioned as follows:		

1	(1) Hospital needs, high priority projects,
2	including training \$ 100,000
3	(2) Education: Classroom construction
4	or repair, other high priority projects, including
5	training
6	Section 4. The sum of \$150,000, or so much thereof as may be
7	necessary, is hereby appropriated from the General Fund of the
8	Federated States of Micronesia for the fiscal year ending September
9	30, 1999, for the purpose of meeting the needs of primary and
10	secondary public schools and State hospitals and State-administered
11	public health programs in the State of Kosrae. The funds
12	appropriated under this section shall be disbursed and used for
13	educational, hospital and public health purposes, excluding any
14	disbursement for salaries, travel, training, or vehicles.
15	Section 5. All funds appropriated by this act shall be
16	allotted, managed, administered, and accounted for in accordance
17	with applicable law, including, but not limited to, the Financial
18	Management Act of 1979. The allottee of the funds appropriated
19	under section 1(1) of this act shall be the Project Coordinator for
20	the Mortlocks or his designee. The allottee of the funds
21	appropriated under section 1(2) of this act shall be the Executive
22	Director of the Northern Namoneas Development Authority or his
23	designee. The allottee of the funds appropriated under section 1(3)
24	of this act shall be the Executive Director of the Southern Namoneas
25	Development Authority. If the Southern Namoneas Development

1 Authority shall be abolished pursuant to Chuuk State law, the 2 Southern Namoneas Development Authority shall be deemed to be, and 3 shall be treated as, a continuing entity for the purposes of this 4 measure. The allottee of the funds appropriated under section 1(4) 5 of this act shall be the Mayor of Polle. The allottee of the funds 6 appropriated under section 1(5) of this act shall be the Northwest Islands Project Coordinator or his designee. The allottee of the 7 funds appropriated under section 1(6) of this act shall be the 8 Secretary of the Department of Health, Education and Social Affairs 9 10 of the Federated States of Micronesia, or his designee. The allottee of the funds appropriated under section 3 of this act shall 11 be the Governor of the State of Yap or the Governor's designee, who 12 shall consult with the Yap delegation prior to obligation of funds 13 appropriated under that section. The allottee of the funds 14 appropriated under section 4 of this act shall be the Governor of 15 the State of Kosrae or the Governor's designee. The allottee of all 16 others funds appropriated by this act shall be the President of the 17 Federated States of Micronesia or the President's designee. 18 allottees shall be responsible for ensuring that these funds, or so 19 much thereof as may be necessary, are used solely for the purpose 20 specified in this act, and that no obligations are incurred in 21 excess of the sum appropriated. The authority of the allottees to 22 obligate funds appropriated by this act shall not lapse. 23 24
