A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by further amending section 2, as amended by Public Laws Nos. 9-104 and 9-137, to modify the use of certain funds appropriated for public projects in Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 9-100, as amended by
2 Public Laws Nos. 9-104 and 9-137, is hereby further amended to
3 read as follows:


4 "Section 2. The sum of \$1,100,000, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 1997, for the
8 purpose of funding the development needs of the State of
9 Kosrae. The funds appropriated by this section shall be
10 apportioned as follows:

- 11 (1) Farmer's Coop. purchase of
- 12 agriculture produce..... \$25,000
- 13 (2) Kosrae Utility Authority standby
- 14 generator, distribution extension and upgrade 165,000
- 15 (3) State agriculture research center.. 100,000
- 16 (4) Tourism development..... ~~AD/D/D~~ 20,000
- 17 (5) Kosrae Community Action Program.... 30,000
- 18 (6) Community development
- 19 (a) Senior citizens
- 20 (i) Statewide program..... 20,000
- 21 (ii) Lelu 2,500
- 22 (iii) Tafunsak..... 2,500
- 23 (iv) Malem..... 2,500
- 24 (v) Utwe..... 2,500
- 25 (b) Women's interest..... 20,000

18 Section 2. This act shall become law upon approval by
 19 the President of the Federated States of Micronesia or upon its
 20 becoming law without such approval.
