A BILL FOR AN ACT

To further amend Public Law No. 9-096, as amended by Public Laws Nos. 9-105, 9-122, and 9-142, by further amending section 13, as amended by Public Law No. 9-142, to modify the use of certain funds appropriated therein for the State of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 13 of Public Law No. 9-096, as amended  
2 by Public Law No. 9-142, is hereby further amended to read as  
3 follows:


4 "Section 13. Development budget - Appropriation. The  
5 sum of \$1,541,447, or so much thereof as may be  
6 necessary, is hereby appropriated from the General Fund  
7 of the Federated States of Micronesia for the fiscal  
8 year ending September 30, 1997, for capital improvement  
9 and development programs and projects of the National  
10 Government of the Federated States of Micronesia during  
11 fiscal year 1997. Of the funds appropriated under this  
12 section, \$1,241,447 shall be deemed to come from the  
13 capital account of the Compact of Free Association.  
14 The sum appropriated by this section shall be  
15 apportioned as follows:

- 16 (1) National staff upgrading program
  - 17 (a) National Judiciary staff
  - 18 training..... \$ 20,000
  - 19 (b) Congress staff training..... 10,000
  - 20 (c) Public Auditor staff training. 10,000
  - 21 (d) Undedicated staff training.... 90,000
- 22 (2) Business development loan fund..... -0-
- 23 (3) Nationwide Board of environmental
- 24 and sustainable development..... 20,000
- 25 (4) Labor Consultant..... 45,000
