A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by further amending section 3, as amended by Public Laws Nos. 9-104, 9-137, 9-158 and 10-20, to modify the use of certain funds, and by further amending section 5, as amended by Public Laws Nos. 9-104, 9-137, 9-151 and 10-20, to change allottees, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 9-100, as amended by Public Laws Nos. 9-104,
2 9-137, 9-158 and 10-20 is hereby further amended to read as follows:

3 "Section 3. The sum of \$4,347,000, or so much thereof as may be necessary,
4 is hereby appropriated from the fiscal year ending September 30, 1997, for the
5 purpose of funding the infrastructure, transportation, and other development
6 needs of the State of Pohnpei. The funds appropriated under this section shall
7 be apportioned as follows:

8 (1) To fund infrastructure development needs, social development
9 programs, and purchase and operation of equipment for transportation needs

19 Section 2. Section 5 of Public Law No. 9-100, as amended by Public Laws Nos. 9-104,
 20 9-137, 9-151 and 10-20, is hereby further amended to read as follows:

21 "Section 5. All funds appropriated by this act shall be allotted, managed,
 22 administered, and accounted for in accordance with applicable law, including, but
 23 not limited to, the Financial Management Act of 1979. The allottee of the funds
 24 appropriated under subsection (1) of section 1 of this act shall be the Governor
 25 of the State of Chuuk. The allottee of the funds appropriated under subsection

1 (2)(a), (2)(b), (2)(c) and (2)(d) of section 1 of this act shall be the Tolesom
2 Authority. The allottees of the funds appropriated under subsection (2)(e) and
3 (2)(f) of section 1 of this act shall be the mayors of the respective
4 municipalities. The allottee of the funds appropriated under subsection (2)(g),
5 (2)(h) and (2)(i) of section 1 of this act shall be the mayor of Polle Municipality.
6 The allottee of the funds appropriated under subsection (3) of section 1 of this
7 act shall be the Southern Namoneas Development Authority. The allottee of the
8 funds appropriated under subsections (4) and (8) of section 1 of this act shall
9 be the Northern Namoneas Development Authority. The allottee of the funds
10 appropriated under subsection (5) of section 1 of this act shall be the Mortlock
11 Development Authority. The allottee of the funds appropriated under
12 subsection (6)(a) of section 1 of this act shall be the Halls Project Coordinator.
13 The allottee of the funds appropriated under subsection (6)(b) of section 1 of
14 this act shall be the Weito Project Coordinator. The allottee of the funds
15 appropriated under subsections (6)(c) and (6)(d) of section 1 of this act shall
16 be the Pattiw Development Authority. The allottee of the funds appropriated
17 under subsection (6)(e) of section 1 of this act shall be the Northwest Islands
18 Project Coordinator. The allottee of the funds appropriated under subsection
19 (7) of section 1 and subsection (2) of section 4 of this act shall be the Speaker
20 of the Congress of the Federated States of Micronesia or the Speaker's
21 designee. The allottee of the funds appropriated under subsection (2) of
22 section 2 of this act shall be the Chairman of the Kosrae Utilities Authority, and
23 the allottee of the funds appropriated under subsection (9) of section 2 of this
24 act shall be the Governor of the State of Kosrae. The allottee of the funds
25 appropriated under subsection (1)(a)(i) of section 3 of this act shall be the


1 Mayor of Kolonia Town. The allottee of the funds appropriated under
2 subsections (1)(a)(ii)a), (1)(a)(ii)b), and (1)(a)(ii)c) of section 3 of this act
3 shall be the Pohnpei Transportation Authority. The allottee of the funds
4 appropriated under subsection (1)(a)(ii)d) of section 3 of this act shall be the
5 Chief Magistrate of Sokehs Municipality. The allottee of the funds appropriated
6 under subsection (1)(b) of section 3 of this act shall be the Vice President of
7 the Federated States of Micronesia or the Vice President's designee. The
8 allottee of the funds appropriated under subsection (2)(a) and (2)(b) of
9 section 3 of this act shall be the Pohnpei Visitor's Bureau. The allottee of the
10 funds appropriated under subsections (1) and (3) of section 4 of this act shall
11 be the Governor of the State of Yap. The allottee of all other funds
12 appropriated by this act shall be the President of the Federated States of
13 Micronesia or the President's designee. The allottees shall be responsible for
14 ensuring that these funds, or so much thereof as may be necessary, are used
15 solely for the purpose specified in this act, and that no obligations are incurred
16 in excess of the sum appropriated. The allottee of the funds appropriated
17 under subsection (1)(b) of section 3 of this act shall not obligate any funds
18 appropriated therein without first consulting with the members of the Pohnpei
19 Delegation to Congress. The authority of the allottees to obligate funds
20 appropriated by this act shall not lapse."

21 Section 3. This act shall become law upon approval by the President of the Federated
22 States of Micronesia or upon its becoming law without such approval.
