A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by further amending section 5, as amended by Public Laws Nos. 9-104, 9-137, 9-151, 10-20 and 10-44, to limit the use of funds and to establish consultation procedures for allottees, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 9-100, as amended by Public Laws Nos. 9-104, 9-
2 137, 9-151, 10-20 and 10-44, is hereby further amended to read as follows:

3 "Section 5. All funds appropriated by this act shall be allotted, managed,
4 administered, and accounted for in accordance with applicable law, including, but not
5 limited to, the Financial Management Act of 1979. The allottee of the funds
6 appropriated under subsection (1) of section 1 of this act shall be the Governor of the
7 State of Chuuk. The allottee of the funds appropriated under subsection (2)(a),
8 (2)(b), (2)(c) and (2)(d) of section 1 of this act shall be the Toleisom Authority. The
9 allottees of the funds appropriated under subsection (2)(e) and (2)(f) of section 1 of
10 this act shall be the mayors of the respective municipalities. The allottee of the funds
11 appropriated under subsection (2)(g), (2)(h) and (2)(i) of section 1 of this act shall
12 be the mayor of Polle Municipality. The allottee of the funds appropriated under
13 subsection (3) of section 1 of this act shall be the Southern Namoneas Development
14 Authority. The allottee of the funds appropriated under subsections (4) and (8) of
15 section 1 of this act shall be the Northern Namoneas Development Authority. The
16 allottee of the funds appropriated under subsection (5) of section 1 of this act shall
17 be the Mortlock Development Authority. The allottee of the funds appropriated under
18 subsection (6)(a) of section 1 of this act shall be the Halls Project Coordinator. The
19 allottee of the funds appropriated under subsection (6)(b) of section 1 of this act
20 shall be the Weito Project Coordinator. The allottee of the funds appropriated under
21 subsections (6)(c) and (6)(d) of section 1 of this act shall be the Pattiw Development
22 Authority. The allottee of the funds appropriated under subsection (6)(e) of section 1
23 of this act shall be the Northwest Islands Project Coordinator. The allottee of the
24 funds appropriated under subsection (7) of section 1 and subsection (2) of section 4
25 of this act shall be the Speaker of the Congress of the Federated States of Micronesia


1 or the Speaker's designee. The allottee of the funds appropriated under subsection
2 (2) of section 2 of this act shall be the Chairman of the Kosrae Utilities Authority, and
3 the allottee of the funds appropriated under subsection (9) of section 2 of this act
4 shall be the Governor of the State of Kosrae. The allottee of the funds appropriated
5 under subsection (1)(a)(i) of section 3 of this act shall be the Mayor of Kolonia Town.
6 The allottee of the funds appropriated under subsections (1)(a)(ii)a), (1)(a)(ii)b), and
7 (1)(a)(ii)c) of section 3 of this act shall be the Pohnpei Transportation Authority. The
8 allottee of the funds appropriated under subsection (1)(a)(ii)d) of section 3 of this act
9 shall be the Chief Magistrate of Sokehs Municipality. The allottee of the funds
10 appropriated under subsection (1)(b) of section 3 of this act shall be the Vice
11 President of the Federated States of Micronesia or the Vice President's designee. The
12 allottee of the funds appropriated under subsection (2)(a) and (2)(b) of section 3 of
13 this act shall be the Pohnpei Visitor's Bureau. The allottee of the funds appropriated
14 under subsections (1) and (3) of section 4 of this act shall be the Governor of the
15 State of Yap. The allottee of all other funds appropriated by this act shall be the
16 President of the Federated States of Micronesia or the President's designee. The
17 allottees shall be responsible for ensuring that these funds, or so much thereof as may
18 be necessary, are used solely for the purpose specified in this act, and that no
19 obligations are incurred in excess of the sum appropriated. The allottees of the funds
20 appropriated under subsection (1)(a) and (1)(b) of section 3 of this act shall not
21 obligate any funds appropriated therein without first consulting with the members of
22 the Pohnpei Delegation to Congress representing the Election District to which the
23 funds are apportioned. The allottees of funds appropriated under subsection (1)(a)
24 of section 3 of this act shall not obligate or expend any funds apportioned under said
25 subsection for travel. The authority of the allottees to obligate funds appropriated by

1 this act shall not lapse."

2 Section 2. This act shall become law upon approval by the President of the Federated
3 States of Micronesia or upon its becoming law without such approval.
