A BILL FOR AN ACT

To amend Public Law No. 10-24, as amended by Public Law No. 10-32, by amending section 12, to correct an error of \$55,400 in the total amount appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 12 of Public Law No. 10-24 is hereby  
2 amended to read as follows:

3 "Section 12. Compact section 221(b) programs. The sum  
4 of ~~\$370,524~~ 425,924, or so much thereof as may be  
5 necessary, is hereby appropriated from the General Fund  
6 of the Federated States of Micronesia for the fiscal  
7 year ending September 30, 1998, for Compact section  
8 221(b) programs and projects of the National Government  
9 of the Federated States of Micronesia during fiscal year  
10 1998. The funds appropriated under this section shall  
11 be deemed to come from funds available under section  
12 221(b) of the Compact of Free Association. The sum  
13 appropriated by this section shall be apportioned as  
14 follows:
