A BILL FOR AN ACT

To further amend Public Law No. 10-24, as amended by Public Law No. 10-32, by amending section 2, to further specify the use of funds appropriated therein for the Pohnpei Delegation Office, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 10-24 is hereby
2 amended to read as follows:

3 "Section 2. Operating expenses of the Legislative
4 Branch. The sum of \$2,931,100, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia
7 for the fiscal year ending September 30, 1998, for
8 the operations of the Legislative Branch of the
9 National Government of the Federated States of
10 Micronesia during fiscal year 1998. The sum
11 appropriated by this section shall be apportioned as
12 follows:

- 13 (1) Office of the Speaker and Members
 - 14 (a) Personnel expenses..... \$ 400,100
 - 15 (b) Travel..... 459,200
 - 16 (funds may also be used for the chartering of vessels
 - 17 to outer islands)
 - 18 (c) Contractual services, grants, subsidies,
 - 19 and contributions 319,800
 - 20 (d) Others..... 100,000
- 21 (2) Staff Offices
 - 22 (a) Personnel expenses..... 787,100
 - 23 (b) Travel..... 124,000
 - 24 (c) Recruitment and repatriation... 30,000
 - 25 (d) Contractual services, grants, subsidies,
