A BILL FOR AN ACT

To further amend Public Law No. 9-027, as amended by Public Laws Nos. 9-083 and 9-113, by further amending section 5, as amended by Public Law No. 9-083, to change an allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:


1           Section 1. Section 5 of Public Law No. 9-027, as amended by Public Law No. 9-  
2   083, is hereby further amended to read as follows:

3                   "Section 5. All funds appropriated by this act shall be allotted, managed,  
4                   administered, and accounted for in accordance with applicable law,  
5                   including, but not limited to, the Financial Management Act of 1979. All  
6                   funds appropriated herein shall not lapse until fully expended. The allottee  
7                   of the funds appropriated under subsections (1) ~~and (2)~~ of section 1 of  
8                   this act shall be the Director of Health Services, Chuuk State. The allottee  
9                   of the funds appropriated under subsection (2) of section 1 of this act  
10                  shall be the Mayor of Polle Municipality. The allottee of the funds  
11                  appropriated under subsection (3) of section 1 of this act shall be the  
12                  Southern Namoneas Authority. The allottee of the funds appropriated  
13                  under subsection (4) of section 1 of this act shall be the Northern  
14                  Namoneas Development Authority. The allottee of the funds appropriated  
15                  under subsection (5) of section 1 of this act shall be the Mortlocks  
16                  Development Authority. The allottee of the funds appropriated under  
17                  subsection (6) of section 1 of this act shall be the Pattiw Development  
18                  Authority. The allottee of the funds appropriated under section 2 of this  
19                  act shall be the Governor of Pohnpei State. The allottee of the funds  
20                  appropriated under section 3 of this act shall be the Governor of Yap  
21                  State. The allottee of the funds appropriated under section 4 of this act  
22                  shall be the Governor of Kosrae State. The allottees shall be responsible  
23                  for ensuring that these funds, or so much thereof as may be necessary,  
24                  are used solely for the purpose specified in this act, and that no obligations  
25                  are incurred in excess of the sum appropriated."

1 Section 2. This act shall become law upon approval by the President of the  
2 Federated States of Micronesia or upon its becoming law without such approval.
