A BILL FOR AN ACT

To further amend Public Law No. 8-93, as amended, by further amending section 2, as amended by Public Laws Nos. 8-98, 8-123, 8-137, 9-020 and 9-098, to make the Governor of the State of Chuuk the allottee of funds appropriated therein for the Chuuk High School Library, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:


1 Section 1. Section 2 of Public Law No. 8-93, as amended by Public Laws Nos. 8-  
2 98, 8-123, 8-137, 9-020 and 9-098, is hereby further amended to read as follows:

3 "Section 2. All funds appropriated by this act shall be allotted, managed,  
4 administered, and accounted for in accordance with applicable law, including,  
5 but not limited to, the Financial Management Act of 1979. The allottee of the  
6 funds appropriated under subsection (1)(a)(i), (1)(a)(ii) and (1)(a)(iii) of  
7 section 1 of this act shall be the Tolensom Authority. The allottee of the funds  
8 appropriated under subsection (1)(b) of section 1 of this act shall be the  
9 Northern Namoneas Development Authority. The allottee of the funds  
10 appropriated under subsection (1)(c) of section 1 of this act shall be the  
11 Southern Namoneas Authority. The allottee of the funds appropriated under  
12 subsection (1)(d)(i) and (1)(d)(ii) of section 1 of this act shall be the Pattiw  
13 Development Authority. The allottee of the funds appropriated under  
14 subsection (1)(e)(xiii) of section 1 of this act shall be the Lower Mortlocks  
15 Development Authority. The allottee of the funds appropriated under  
16 subsection (1)(g) of section 1 of this act shall be the Governor of the State of  
17 Chuuk. The allottee of the funds appropriated under subsection (4) of section  
18 1 of this act shall be the Governor of the State of Yap or his designee. The  
19 allottee of all other funds appropriated by this act shall be the President of  
20 the Federated States of Micronesia or the President's designee. The allottees  
21 shall be responsible for ensuring that these funds, or so much thereof as may  
22 be necessary, are used solely for the purpose specified in this act, and that no  
23 obligations are incurred in excess of the sum appropriated. The authority of  
24 the allottees to obligate funds appropriated by this act shall not lapse."

1 Section 2. This act shall become law upon approval by the President of the  
2 Federated States of Micronesia or upon its becoming law without such approval.
