A BILL FOR AN ACT

To further amend Public Law No. 8-113, as amended, by further amending section 6, as amended by Public Laws Nos. 8-129, 9-036, and 9-146, to change the lapse date, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 6 of Public Law No. 8-113, as  
2 amended by Public Laws Nos. 8-129, 9-036, and 9-146, is  
3 hereby further amended to read as follows:  
4           "Section 6. All funds appropriated by this act  
5 shall be allotted, managed, administered, and  
6 accounted for in accordance with applicable law,  
7 including, but not limited to, the Financial  
8 Management Act of 1979. The allottee of the funds  
9 appropriated under subsection (1)(a) of section 1  
10 of this act shall be the Mayor of Udot. The  
11 allottee of the funds appropriated under  
12 subsection (1)(b) of section 1 of this act shall  
13 be the Mayor of Tolensom. The allottee of the  
14 funds appropriated by subsection (2) of section 1  
15 of this act shall be the Southern Namoneas  
16 Authority. The allottee of the funds appropriated  
17 by subsection (3) of section 1 of this act shall  
18 be the Northern Namoneas Development Authority.  
19 The allottee of the funds appropriated by  
20 subsection (4) of section 1 of this act shall be  
21 the Lower Mortlocks Development Authority. The  
22 allottee of the funds appropriated by subsection  
23 (5)(a) of section 1 of this act shall be the  
24 Pattiw Development Authority. The allottee of the  
25 funds appropriated by subsection (6) of section 1

1 of this act shall be the Executive Director of the  
2 Chuuk Organization for Community Action. The  
3 allottee of the funds appropriated by subsection  
4 (7) of section 1 of this act shall be the Governor  
5 of Chuuk State. The allottee of the funds  
6 appropriated under subsection (8) of section 1 of  
7 this act shall be the Speaker of the Congress of  
8 the Federated States of Micronesia. The allottee  
9 of the funds appropriated by sections 2, 4 and 5  
10 of this act shall be the President of the  
11 Federated States of Micronesia, or the President's  
12 designee. The allottee of the funds appropriated  
13 under section 3 of this act shall be the Governor  
14 of the State of Yap. The allottees shall be  
15 responsible for ensuring that these funds, or so  
16 much thereof as may be necessary, are used solely  
17 for the purpose specified in this act, and that no  
18 obligations are incurred in excess of the sum  
19 appropriated. The authority of the allottees to  
20 obligate funds appropriated by this act shall  
21 lapse as of September 30, 199~~8~~9."
