A BILL FOR AN ACT

To appropriate the sum of \$399,536 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, to fund the FSM National Language and Cultural Institute established in accordance with the FSM Language Policy, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$399,536, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of
3 the Federated States of Micronesia for the fiscal year ending
4 September 30, 1999, to fund the initial two years of operations
5 for the FSM National Language and Cultural Institute
6 established in accordance with the FSM Language Policy. The
7 sum appropriated by this section shall be apportioned as
8 follows:

9	(1) First year only costs	
10	(a) Computers and printer.....	\$ 32,500
11	(b) Furniture.....	3,000
12	(2) Two-year operational costs	
13	(a) Full time personnel	
14	(\$74,535 x 2).....	149,070
15	(b) Work-study students

1 Section 2. All funds appropriated by this act shall be
2 allotted, managed, administered, and accounted for in accordance
3 with applicable law, including, but not limited to, the
4 Financial Management Act of 1979. The allottee of the funds
5 appropriated by this act shall be the President of the College
6 of Micronesia-FSM. The allottee shall be responsible for
7 ensuring that these funds, or so much thereof as may be
8 necessary, are used solely for the purpose specified in this
9 act, and that no obligations are incurred in excess of the sum
10 appropriated. The authority of the allottee to obligate funds
11 appropriated by this act shall lapse as of September 30, 2000.

12 Section 3. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its
14 becoming law without such approval.
