A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended by Public Law No. 10-122, by amending section 2, as amended by Public Law No. 10-122, for the purpose of reprogramming certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 10-120, as  
2 amended by Public Law No. 10-122, is hereby further amended to  
3 read as follows:

4 "Section 2. The sum of \$1,000,000, or so much  
5 thereof as may be necessary, is hereby appropriated  
6 from the General Fund of the Federated States of  
7 Micronesia for the fiscal year ending September 30,  
8 1999, for the purpose of funding infrastructure and  
9 other projects and programs in the State of Kosrae.  
10 The funds appropriated under this section shall be  
11 apportioned as follows:


