

AN ACT

To further amend Public Law No. 8-118, as amended by Public Laws Nos. 8-136, 8-138, and 9-023, by further amending section 1, as amended by Public Law No. 8-136, by amending section 2, and by further amending section 3, as amended by Public Laws Nos. 8-138 and 9-023, to modify the use of certain funds in the Mortlocks and in Faichuk, and to change an allottee, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 1 of Public Law No. 8-118, as amended by Public Law No. 8-136, is hereby further amended to read as follows:

"Section 1. The sum of \$446,120, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of constructing and/or improving roads, docks and/or airports and funding other economic or social projects in Chuuk State. The sum appropriated under this section shall be apportioned as follows:

Section 2. Section 2 of Public Law No. 8-118 is hereby amended to read as follows:

"Section 2. The sum of \$875, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of constructing and/or improving roads, bridges and causeways, and for funding economic and social development projects in Faichuk, Chuuk State."

Section 3. Section 3 of Public Law No. 8-118, as amended by Public Law No. 8-138 and 9-023, is hereby further amended to read as follows:

"Section 3. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsection (1) of section 1 of this act shall be the President of the Federated States of Micronesia. The allottee of the funds appropriated under subsection (2) of section 1 of this act shall be the Northern Namoneas Development Authority. The allottee of the funds appropriated under subsection (3) of section 1 of this act shall be the Lower Mortlocks Development Authority. The allottee of funds appropriated under subsection (4)(a), (4)(b), and (4)(c) of section 1 of this act shall be the Pattiw Social and Economic Development Authority. The allottee of the funds appropriated under section 2 of this act shall be the Tolensom Development Authority. The allottees shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum appropriated. The authority of the allottee to obligate funds appropriated by this act shall not lapse."

Section 4. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
