## A BILL FOR AN ACT

To appropriate the sum of \$32,600 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, to fund the National Women's Advisory Council's Fifth FSM Women's Conference, scheduled to be held in Pohnpei State from August 2-6, 1999, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

BE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The Congress of the Federated States of Micronesia
2	recognizes the important work of the National Women's Advisory
3	Council in the promotion and advancement of the status of women in
4	the nation. The purpose of this appropriation is to provide the
5	National Women's Advisory Council with sufficent funding to prepare
6	for and host the Fifth FSM Women's Conference, scheduled to be held
7	in Pohnpei, from August 2-6, 1999.
8	Section 2. The sum of \$32,600, or so much thereof as may be
9	necessary, is hereby appropriated from the General Fund of the
10	Federated States of Micronesia for the fiscal year ending September
11	30, 1999, for the purpose of funding travel, administrative
12	expenses, and the purchase of supplies associated with the planning
13	for and hosting of the Fifth FSM Women's Conference, in furtherance
14	of the goals stated in section 1 herein. The sum appropriated by
15	this section shall be apportioned as follows:
16	(1) Contractual services \$ 10,000
17	(2) Travel expenses for representatives from
18	Yap, Chuuk, Kosrae and neighboring islands
19	(3) Administrative expenses, including
20	communication, supplies, materials and reproduction
21	expenses 6,000
22	(4) Word processing equipment 3,000
23	Section 3. Allotment and management of funds and lapse date.
24	(1) All funds appropriated by this act shall be allotted,

25 managed, administered, and accounted for in accordance with

1 applicable law, including, but not limited to, the Financial

- 2 Management Act of 1979. The allottee of the funds appropriated by
- 3 this act shall be the President of the Federated States of
- 4 Micronesia or the President's designee. The allottee shall be
- 5 responsible for ensuring that these funds, or so much thereof as may
- 6 be necessary, are used solely for the purpose specified in this act,
- and that no obligations are incurred in excess of the sum
- appropriated.
- (2) The authority of the allottee to obligate funds 9
- 10 appropriated by this act shall lapse as of September 30, 1999.
- 11 Section 4. This act shall become law upon approval by the
- President of the Federated States of Micronesia or upon its becoming 12

law without such approval. 13
