25	Section 7. Title 39 of the Code of the Federated States of

23	representation of persons who have:

3	(c) major business use of, and by reason thereof,
4	a vested interest in, postal services;
5	(d) not been convicted of any felony.
6	(3) The Board shall elect, among its members, a
7	chairman who shall convene and preside over meetings of
8	the Board. The chairman shall perform such other duties
9	as may be prescribed by the Corporation bylaws, as
10	assigned from time to time by the Board, or as provided
11	in this act. The chairman shall serve for a term of
12	three (3) years. The Board shall elect among its members
13	a vice chairman who shall, in the absence of the
14	chairman, have and perform all the functions and duties
15	of the chairman. The vice chairman shall serve for a
16	term of three (3) years.
17	(4) With the exception of the Postmaster General, who
18	serves as a director for as long as he is the Postmaster
19	General, every director shall hold office for a term of
20	three (3) years.
21	(5) A director whose term expires after three (3) years
22	shall be eligible for reappointment.

24	affirmative vote of four (4) Board members.
25	(7) Except as provided by this act, each director shall

8	(1) In addition to the removal provisions in section

13	or incompetence proved to the satisfaction of the Board.
14	(2) An extraordinary vacancy shall be filled by the
15	appointment of a person in the same manner prescribed in
16	section 122 of this chapter.
17	(3) Every person appointed to fill an extraordinary
18	vacancy shall be appointed for the remaining term for
19	which the vacating director was appointed."
20	Section 11. Title 39 of the Code of the Federated States of
21	Micronesia, as amended by Public Laws Nos. 5-66 and 7-75, is hereby
22	further amended by adding a new section 124 of chapter 1 to read as
23	follows:
24	"Section 124. Board meetings.
25	(1) The first meeting of the Board shall be called by

1	the Postmaster General within sixty (60) days after all
2	directors are appointed and qualified.
3	(2) Subsequent meetings of the Board shall be held at
4	such times and places as the Board, from time to time,
5	determines.
6	(3) The chairman or any three (3) directors may at
7	any time call a special meeting of the Board.
8	(4) At all meetings of the Board the quorum necessary
9	for the transaction of business shall be a simple
10	majority of the directors.
11	(5) A resolution in writing, signed or assented to by
12	letter or facsimile by all directors, shall be valid and
13	effectual as if it had been passed at a meeting of the
14	directors duly called and constituted.
15	(6) The Board shall cause minutes to be kept, in a book
16	provided for that purpose, of all resolutions and
17	proceedings of its meetings.
18	(7) The minutes shall be approved by the Board and
