A BILL FOR AN ACT

To amend Public Law No. 11-23, by amending section 8(4)(c) to appropriate the sum of \$160,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2000, to reinstate funding for an Agreement for the Joint Administration of Law Enforcement Between the National Government of the Federated States of Micronesia and the Government of Chuuk, and for other purposes.
