A BILL FOR AN ACT

To further amend Public Law No. 10-26, as amended by Public Law 10-131, by further amending sections 1 and 2, as amended by Public Law No. 10-131, for the purpose of broadening the uses of certain funds apportioned to the State of Kosrae and extending the lapse date, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 10-26, as amended by
2	Public Law No. 10-131, is hereby further amended to read as follows:
3	"Section 1. The sum of \$800,000, or so much thereof as
4	may be necessary, is hereby appropriated from the General
5	Fund of the Federated States of Micronesia for the fiscal
6	year ending September 30, 1998, to provide funding for
7	new National Government office buildings or other State
8	or National Government capital projects in each of the
9	four States of the Federated States of Micronesia. The
10	funds appropriated herein shall be deemed to come from
11	the Capital Account of the Compact of Free Association
12	and shall be available to defray the cost of leasing or
13	purchasing land, making improvements to land, and
14	construction, purchase, long-term lease, or capital
15	improvement of delegation office buildings or to
16	facilitate other State or National Government capital
17	projects. The funds appropriated herein shall be
18	apportioned as follows:
19	(1) State of Pohnpei\$ 250,000
20	(2) State of Yap 200,000
21	(3) State of Chuuk
22	(4) State of Kosrae
23	(a) Lelu shoreline protection 10,000
24	(b) Malem shoreline protection 10,000
25	(c) Utwe shoreline protection 10,000

1	(d) Tafunsak shoreline protection\$ 10,000
2	(e) Walung shoreline protection
3	and bridge
4	(f) Land acquisition or state-wide
5	shoreline protection
6	Section 2. Section 2 of Public Law No. 10-26, as amended by
7	Public Law No. 10-131, is hereby further amended to read as follows:
8	"Section 2. Allotment and management of funds and lapse
9	<u>date.</u>
10	(1) All funds appropriated by this act shall be
11	allotted, managed, administered, and accounted for in
12	accordance with applicable law, including, but not
13	limited to, the Financial Management Act of 1979. The
14	allottee of the funds appropriated under subsection 4 of
15	section 1 of this act shall be the Governor of the State
16	of Kosrae. The allottee of the remaining funds
17	appropriated by this act shall be the President of the
18	Federated States of Micronesia or the President's
19	designee. The allottees shall be responsible for
20	ensuring that these funds, or so much thereof as may be
21	necessary, are used solely for the purpose specified in
22	this act, and that no obligations are incurred in excess
23	of the sum appropriated.
24	(2) The authority of the allottee to obligate funds
25	appropriated under subsection (4)(f) of section 1

1	of this act shall lapse as of September 30, 2001. The
2	authority of the allottee to obligate funds appropriated
3	under <u>all other subsections of</u> section 1 of this act
4	shall lapse as of September 30, 2000."
5	Section 3. This act shall become law upon approval by the
6	President of the Federated States of Micronesia or upon its becoming
7	law without such approval.
