AN ACT

To further amend Public Law No. 10-120, as amended, by further amending section 4, as amended by Public Laws Nos. 10-122 and 11-5, to modify the use of funds appropriated therein for the State of Yap, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 4 of Public Law No. 10-120, as amended by Public Laws Nos. 10-122 and 11-5, is hereby further amended to 2 read as follows: 3 4 The sum of \$1,000,000, or so much thereof "Section 4. 5 as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for 6 7 the fiscal year ending September 30, 1999, for the purpose of funding infrastructure and other projects and 8 9 programs in the State of Yap.
