A BILL FOR AN ACT

To further amend title 54 of the Code of the Federated States of Micronesia, as amended, by amending section 221, as enacted by Public Law No. 9-139, to reduce the import duty on certain classes of products, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 221 of title 54 of the Code of the Federated
2	States of Micronesia, as enacted by Public Law No. 9-139, is hereby
3	amended to read as follows:
4	"Section 221. Levy and rates. The following import duties
5	are hereby levied on all products specified herein which are
6	imported into the FSM:
7	(1) cigarettes, at the rate of twenty-five percent ad
8	valorem;
9	(2) tobacco, other than cigarettes, at the rate of
10	fifty percent ad valorem;
11	(3) perfumery, cosmetics, and toiletries, including cologne
12	and other toilet waters, articles of perfumery, whether in
13	sachets or otherwise, and all preparations used as
14	applications to the hair or skin, lipsticks, pomades,
15	powders, and other toilet preparations not having medicinal
16	properties, at the rate of twenty-five percent ad valorem <u>,</u>
17	provided that primarily hygienic products, such as
18	toothpaste, dental floss, soaps, and shampoos shall be

1 subject to the rate imposed on products under subsection (10) 2 of this section; (4) soft drinks, drink mixes, drink preparations, coffee, 3 4 tea, and nonalcoholic beverages, at the rate of twenty-five percent ad valorem, provided, that drinking water, whether 5 plain, seltzer, soda or mineral, shall be subject to the rate 6 7 imposed on products under subsection (10) of this section; (5) beer and malt beverages, at the rate of twenty-five 8 9 percent ad valorem; 10 (6) distilled alcoholic beverages, at the rate of ten 11 dollars per gallon; (7) wine at the rate of twenty-five percent ad valorem; 12 (8) foodstuffs for human consumption, at the rate of 13 14 three percent ad valorem; [provided, however, that fresh citrus fruit shall be at the rate of twenty-five percent ad 15 valorem; 16 17 (9) gasoline and diesel fuel, at the rate of five cents per 18 gallon; and [(10) laundry bar soap, at the rate of one hundred 19 20 percent ad valorem; and] ([11]10) all other imported products, except those 21 specified above, at the rate of four percent ad 22 valorem." 23 24 Section 2. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming 25
