A BILL FOR AN ACT

To further amend title 1 of the Code of the Federated States of Micronesia, as amended, by adding a new chapter 9 concerning the procedure for the admission of a new state into the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Title 1 of the Code of the Federated States of
- 2 Micronesia, as amended by Public Law No. 10-25, is hereby further
- 3 amended by enacting a new chapter 9, entitled "Admission of New
- 4 States".
- 5 Section 2. Title 1 of the Code of the Federated States of
- 6 Micronesia, as amended by Public Law No. 10-25, is hereby further
- 7 amended by enacting a new section 901 of chapter 9 to read as
- 8 follows:
- 9 "Section 901. <u>Authorization</u>. New states may be formed
- 10 and admitted into the Federated States of Micronesia in
- 11 accordance with the provisions of article I of the
- 12 Constitution of the Federated States of Micronesia and
- this chapter."
- 14 Section 3. Title 1 of the Code of the Federated States of
- 15 Micronesia, as amended by Public Law No. 10-25, is hereby further
- 16 amended by enacting a new section 902 of chapter 9 to read as
- 17 follows:
- "Section 902. <u>Vote Required</u>. No new state shall be
- formed and admitted except upon the affirmative vote of

5	and orderly transition to statehood, including, but not
6	limited to, the following:
7	(1) delineating the territory and boundaries of

9	(2) providing for the establishment of an interim
10	<pre>government;</pre>
11	(3) setting the date by which a constitutional
12	convention must take place in the new state;
13	(4) the date(s) by which national, state, and
14	<pre>local government elections must take place;</pre>
15	(5) the principles and criteria for the equitable
16	division of assets and liabilities between the new
17	state, the predecessor entity, and the Federated States
18	of Micronesia;
19	(6) determining applicable law to apply pending
20	adoption of the new state's constitution and
21	establishment of all levels of government;
22	(7) funding for specified transitional
23	activities; and
24	(8) any other matters contributing to a smooth
25	and orderly transition."

Section 7. Title 1 of the Code of the Federated States of 1 Micronesia, as amended by Public Law No. 10-25, is hereby further amended by enacting a new section 906 of chapter 9 to read as follows: 5 "Section 906. Equal Footing doctrine. Each new state 6 admitted into the Federated States of Micronesia shall 7 be admitted on an equal footing with every other state and shall be subject to the same duties and obligations, 8 9 and accorded the same rights and privileges, as every 10 other state of the Federated States of Micronesia, as 11 provided for in the Constitution of the Federated States of Micronesia." 12 Section 8. Title 1 of the Code of the Federated States of 13 14 Micronesia, as amended by Public Law No. 10-25, is hereby further amended by enacting a new section 907 of chapter 9 to read as 15 16 follows: 17 "Section 907. Interim Government. The existing 18 government(s) of the area approved for admission as a 19 new state of the Federated States of Micronesia shall 20 continue as the interim government(s) until such time as 21 elections are held as set forth in the bill approving 22 admission." Section 9. Title 1 of the Code of the Federated States of 23 24 Micronesia, as amended by Public Law No. 10-25, is hereby further amended by enacting a new section 908 of chapter 9 to read as 25

1	follows:
2	"Section 908. <u>Election of Representatives</u> . A new state
3	shall hold general elections to elect representatives to
4	the Congress of the Federated States of Micronesia
5	within one year of the date of approval for admission
6	into the Federated States of Micronesia."
7	Section 10. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its
9	becoming law without such approval.
