PUBLIC LAW NO. 12-43

AN ACT

To further amend Public Law No. 6-28, as amended, by amending sections 2 and 4 for the purpose of changing the use of certain funds and changing the allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 6-28, as amended by
2	Public Laws Nos. 7-42, 7-137 and 8-43, is hereby further amended
3	to read as follows:
4	"Section 2. The sum appropriated under section 1 of
5	this act shall be apportioned as follows:
6	(1) Pohnpei State
7	(a) Kapingamarangi\$ 300,000
8	(b) Sapwuafik 300,000
9	(2) Chuuk State
10	(a) Northwest airport projects 300,000
11	(b) Ta and other Mortlock islands 300,000
12	(c) Pulusuk 300,000"
13	Section 2. Section 4 of Public Law No. 6-28, as amended by
14	Public Laws Nos. 10-134 and 10-141, is hereby further amended to
15	read as follows:
16	"Section 4. Allotment and management of funds and lapse
17	<u>date</u> .
18	(1) All funds appropriated by this act shall be

1	allotted, managed, administered and accounted for in
2	accordance with applicable law, including, but not
3	limited to, the Financial Management Act of 1979. The
4	allottee of the funds provided under subsection (1)(a)
5	of section 2 of this act shall be the Pohnpei Port
6	Authority. The allottee of the funds provided under
7	subsections (2)(a) and (2)(c) of section 2 of this act
8	shall be the Northwest Project Coordinator. The
9	allottee of the funds provided under subsection (2)(b)
LO	of section 2 of this act shall be the Mortlocks Project
11	Coordinator. The allottees shall be responsible for
12	ensuring that these funds, or so much thereof as may be
13	necessary, are used solely for the purpose specified in
L 4	this act, and that no obligations are incurred in excess
15	of the sum appropriated.
16	(2) The authority of the allottees to obligate funds
L7	appropriated by this act shall not lapse."
