- 4 many citizens of the Federated States of Micronesia who are living
- 5 in the United States; and
- 6 WHEREAS, some of the leaders and representatives of the
- 7 Micronesians United of Hawaii, the Island Tenants on the Rise, and
- 8 the United Church of Christ visited the Federated States of
- 9 Micronesia during the Second Special Session of the Twelfth
- 10 Congress; and
- 11 WHEREAS, these leaders and representatives include the
- 12 Reverend Ron Fujiyoshi of the United Church of Christ, Ms. Monique
- 13 Ocampo, President of the Island Tenants on the Rise, Ms. Traci
- 14 Konrat, Outreach Worker at the Kokua Kalihi Valley Clinic, and Mr.
- 15 Benito Muritok, Ms. Meriko Route, Ms. Maria Narruhn, Mr. Peterson
- 16 Santos, Ahm Sepety, the Reverend Ranet John and Mr. Bruno Lat of
- 17 Micronesians United of Hawaii; and
- 18 WHEREAS, these leaders and representatives met with Members
- 19 of the Congress of the Federated States of Micronesia, the Vice
- 20 President of the Federated States of Micronesia, the staff and

1 members of the Joint Committee on Compact Economic Negotiations,

- 2 the Department of Foreign Affairs, and other appropriate leaders
- 3 and entities of the FSM National Government; and
- WHEREAS, these meetings were held to solicit help and support
- 5 to further the efforts of these non-governmental organizations,
- 6 the United Church of Christ, and the many other supporting
- 7 organizations to assist the many FSM citizens living in the United
- 8 States; and
- 9 WHEREAS, many of these leaders and representatives traveled
- 10 to the Federated States of Micronesia at their own expense to also
- 11 share some of their own personal stories and concerns over issues
- 12 involved in obtaining or reinstituting benefits, such as free
- 13 legal aid, housing assistance, food stamps and health insurance,
- 14 among others; and
- 15 WHEREAS, the Micronesians United of Hawaii, the Island
- 16 Tenants on the Rise, the United Church of Christ, and many other
- 17 non-governmental organizations often provide an influential voice
- 18 on behalf of FSM citizens who seek these benefits and a better
- 19 life in Hawaii and elsewhere in the United States; now, therefore,
- 20 BE IT RESOLVED by the Twelfth Congress of the Federated
- 21 States of Micronesia, Second Special Session, 2002, that the
- 22 Congress expresses its sincere gratitude and appreciation for the
- 23 visit and assistance rendered by the Micronesians United of
- 24 Hawaii, the Island Tenants on the Rise, the United Church of
- 25 Christ, and the many other non-governmental organizations which
- 26 assist FSM citizens living in Hawaii and elsewhere in the United
