

A BILL FOR AN ACT

To further amend Public Law No. 8-115, as amended, by further amending sections 1 and 5, to allow funds appropriated therein to be used for other needs in the State of Chuuk, to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 8-115, as amended by
2 Public Laws Nos. 9-92, 9-107, 10-2, 10-66 and 11-51, is hereby further
3 amended to read as follows:

4 "Section 1. The sum of \$500,000, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund of
6 the Federated States of Micronesia for the fiscal year ending
7 September 30, 1995, to assist State-administered public
8 health programs and for other public projects and programs in
9 the State of Chuuk. The funds appropriated by this section
10 shall be apportioned as follows:

23 Section 2. Section 5 of Public Law No. 8-115, as amended by
 24 Public Laws Nos. 9-33, 9-41, 9-60, 9-92 and 10-37, is hereby further
 25 amended to read as follows:

1 "Section 5. Allotment and Management of funds and lapse
2 date.

3 (1) All funds appropriated by this act shall be allotted,
4 managed, administered, and accounted for in accordance with
5 applicable law, including, but not limited to, the Financial
6 Management Act of 1979. The allottee of the funds
7 appropriated by subsections (1) and (6) of section 1 of this
8 act shall be the Chuuk State Director of Health Services.
9 The allottee of the funds appropriated by subsection (2) of
10 section 1 of this act shall be the Southern Namoneas
11 Development Authority. The allottee of the funds
12 appropriated by subsection (3) of section 1 of this act shall
13 be the Northern Namoneas Development Authority. The allottee
14 of the funds appropriated by subsection (4) of section 1 of
15 this act shall be the Mortlocks [~~Development Authority~~]
16 Projects Commission. The allottee of the funds appropriated
17 by subsection (5) of section 1 of this act shall be the
18 Pattiw Development Authority. The allottee of the funds
19 appropriated by section 2 of this act shall be the Governor
20 of Kosrae or his designee. The allottee of the funds
21 appropriated by subsection (2) of section 3 of this act shall
22 be the Pohnpei Transportation Authority. The allottee of all
23 other funds appropriated by this act shall be the President
24 of the Federated States of Micronesia or the President's
25 designee, PROVIDED, that in the event of a designation by the

1 President of another allottee of funds appropriated by
2 subsection (1) of section 3 of this act, the President shall
3 require that said designee provide a separate accounting to
4 ensure that said funds are used solely for financing
5 improvements to the water supply system in Sokehs
6 Municipality. The allottees shall be responsible for
7 ensuring that these funds, or so much thereof as may be
8 necessary, are used solely for the purpose specified in this
9 act, and that no obligations are incurred in excess of the
10 sum appropriated.

11 (2) Notwithstanding Public Law No. 9-040, the authority of
12 the allottees to obligate funds appropriated by this act
13 shall not lapse."

14 Section 3. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its becoming
16 law without such approval.
