

A BILL FOR AN ACT

To further amend Public Law No. 8-115, as amended, by further amending sections 1 and 5 to allow funds appropriated therein to be used for other needs in the State of Chuuk, to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 8-115, as amended by
2 Public Laws Nos. 10-2, 10-66 and 11-51, is hereby further amended to
3 read as follows:

4 "Section 1. The sum of \$500,000, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund of
6 the Federated States of Micronesia for the fiscal year ending
7 September 30, 1995, to assist State-administered public
8 health programs and for other public projects and programs in
9 the State of Chuuk. The funds appropriated by this section
10 shall be apportioned as follows:

4 Section 2. Section 5 of Public Law No. 8-115, as amended by
 5 Public Law No. 10-37, is hereby further amended to read as follows:

6 "Section 5. Allotment and management of funds and lapse
 7 date.

8 (1) All funds appropriated by this act shall be allotted,
 9 managed, administered, and accounted for in accordance with
 10 applicable law, including, but not limited to, the Financial
 11 Management Act of 1979. The allottee of the funds
 12 appropriated by subsections (1) and (6) of section 1 of this
 13 act shall be the Chuuk State Director of Health Services.
 14 The allottee of the funds appropriated by subsection (2) of
 15 section 1 of this act shall be the [~~Southern Namoneas~~
 16 ~~Development Authority~~] Chuuk State Commission on Improvement
 17 Projects. The allottee of the funds appropriated by
 18 subsection (3) of section 1 of this act shall be the Northern
 19 Namoneas Development Authority. The allottee of the funds
 20 appropriated by subsection (4) of section 1 of this act shall
 21 be the [~~Mortlocks Development Authority~~] Vice President of
 22 the Federated States of Micronesia, or his designee. The
 23 allottee of the funds appropriated by subsection (5) of
 24 section 1 of this act shall be the Pattiw Development
 25 Authority. The allottee of the funds appropriated by section

1 2 of this act shall be the Governor of Kosrae or his
2 designee. The allottee of the funds appropriated by
3 subsection (2) of section 3 of this act shall be the Pohnpei
4 Transportation Authority. The allottee of all other funds
5 appropriated by this act shall be the President of the
6 Federated States of Micronesia or the President's designee,
7 PROVIDED, that in the event of a designation by the President
8 of another allottee of funds appropriated by subsection (1)
9 of section 3 of this act, the President shall require that
10 said designee provide a separate accounting to ensure that
11 said funds are used solely for financing improvements to the
12 water supply system in Sokehs Municipality. The allottees
13 shall be responsible for ensuring that these funds, or so
14 much thereof as may be necessary, are used solely for the
15 purpose specified in this act, and that no obligations are
16 incurred in excess of the sum appropriated.

17 (2) Notwithstanding Public Law No. 9-040, the authority of
18 the allottees to obligate funds appropriated by this act
19 shall not lapse."

20 Section 3. This act shall become law upon approval by the
21 President of the Federated States of Micronesia or upon its becoming
22 law without such approval.
