A BILL FOR AN ACT

To amend Public Law No. 13-37 by amending section 1 thereof and by adding new sections 2 and 3 thereto to clarify the amount of funds appropriated to each of the uses identified therein, by amending the existing section 3 thereof to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 13-37 is hereby 2 amended to read as follows: 3 "Section 1. The sum of \$[234,153] <u>100,000</u>, or so much thereof as may be necessary, is hereby appropriated from 4 the General Fund of the Federated States of Micronesia 5 6 for the fiscal year ending September 30, 2004, for the 7 purpose of funding costs associated with the hosting, by 8 the FSM Congress, of the 2004 Asian-Pacific 9 Parliamentarians' Union General Assembly and Council 10 Meeting [, and of Congress' receiving Foreign visitors 11 and dignitaries and obligations and operations 12 requirements of Joint Compact Negotiation 13 expenditures]." 14 Section 2. Public Law No. 13-37 is hereby amended by adding a new section 2 to read as follows: 15 16 "Section 2. The sum of \$20,000, or so much thereof as may be need 17 purpose of funding costs associated with Congress' 18 receiving of foreign visitors and dignitaries."

1	Section 3. Public Law No. 13-37 is hereby amended by adding
2	a new section 3 to read as follows:
3	"Section 3. The sum of \$114,153, or so much thereof as may be n
4	purpose of funding the operations of the Joint Committee
5	on Compact Negotiations."
6	Section 4. Public Law No. 13-37 is hereby amended by
7	renumbering section 3 thereof as section 4, and amending said
8	section to read as follows:
9	"Section [3] <u>4</u> . <u>Allotment and management of funds and lapse dat</u>
10	(1) All funds appropriated by this act shall be
11	allotted, managed, administered, and accounted for in
12	accordance with applicable law, including, but not
13	limited to, the Financial Management Act of 1979. The
14	allottee of the funds appropriated by <u>sections 1 and 2</u>
15	of this act shall be the Speaker of the Thirteenth
16	Congress of the Federated States of Micronesia, or his
17	designee. The allottee of the funds appropriated by
18	section 3 of this act shall be the President of the
19	Federated States of Micronesia. The allottees shall be
20	responsible for ensuring that these funds, or so much
21	thereof as may be necessary, are used solely for the
22	purpose specified in this act, and that no obligations
23	are incurred in excess of the sum appropriated.
24	(2) The authority of the allottee to obligate funds
25	appropriated by this act shall lapse as of September 30,

2	Section 5. This act shall become law upon approval by the
3	President of the Federated States of Micronesia or upon its
4	becoming law without such approval.
