The allottee of the funds appropriated 9 under subsection (12) of section 1 of this act shall 10 be the Peace Corps Representative, Chuuk State. The 11 allottees of the funds appropriated by sections [3], 5, 6, 7, 8, and 9 of this act shall be the local 12 13 development authorities of the areas for which the 14 projects are designated. The allottees shall be responsible for ensuring that these funds, or so 15 16 much thereof as may be necessary, are used solely 17 for the purposes specified in this act, and that no obligations are incurred in excess of the sum 18 19 appropriated. The authority of the allottees to 20 obligate funds appropriated by this act shall not 21 lapse until expended."
