## A BILL FOR AN ACT

To further amend Public Law No. 12-50, as amended, by amending section 8 thereof, to clarify the use of certain funds appropriated for State Judiciaries and to broaden the use of certain funds appropriated for the Chuuk Judiciary, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
