A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended, by amending section 1 and 6 thereof to modify the use of certain funds appropriated for use in Chuuk State, to change the allottee to certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 10-120, as amended by Public Laws Nos. 10-122, 10-144, 11-8, 11-20, 11-32, 12-6, 12-20, 12-68 and 13-11, is hereby further amended to read as follows: "Section 1. The sum of \$5,000,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for 6 the fiscal year ending September 30, 1999, for the 8 purpose of funding infrastructure and other projects and 9 programs in the State of Chuuk. The funds appropriated 10 under this section shall be apportioned as follows: 11 (1) Regional transportation projects 12 (which shall be deemed to come from capital 13 account funds available under section 211 of the Compact 14 of Free Association) 15 (a) Ta airport paving and related 16 structures and equipment\$ 200,000 17 (b) Houk airport paving, including acquisition of related structures and 18 19 250,000 equipment

Section 6 of Public Law No. 10-120, as amended by 7 Public Laws Nos. 10-122, 11-8, 11-10, 11-20, 11-32, 11-64. 11-75. 12-20, 12-47. 12-68 and 13-11, is hereby further amended to read as follows: 10 "Section 6. Allotment and management of funds and lapse 11 date. 12 (1) All funds appropriated by this act shall be allotted, managed, administered, and accounted for in 13 14 accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. 15 16 allottee of the funds appropriated under section 1(3)(e) 17 of this act shall be the Governor of the State of Chuuk 18 or his designee. The allottee of the funds appropriated 19 under section 1(2) of this act shall be the Speaker of 20 the Congress of the Federated States of Micronesia. The 21 allottee of the funds appropriated under section 1(3)(a) 22 of this act shall be the Director of the Department of Health Services. The allottee of the funds appropriated 23 24 under section 1(3)(c) of this act shall be the Assistant 25 Director, Land Grant Program, Cooperative Extension

1 Services, Chuuk State. The allottee of the funds 2 appropriated under section 1(3)(d) of this act shall be 3 the Executive director of the Chuuk Recreation Office. 4 The allottee of the funds appropriated under section 1(3)(f) of this act shall be the Secretary of the 5 6 Department of Health, Education and Social Affairs of 7 the Federated States of Micronesia, or his designee. 8 The allottee of the funds appropriated under section 9 1(3)(q) of this act shall be the Chuuk State Commission 10 on Improvement Projects. The allottee of the funds appropriated under section 1(5) and 1(3)(b) of this act 11 shall be the Executive Director of the Northern Namoneas 12 13 Development Authority, or if the Northern Namoneas 14 Development Authority shall be abolished, the Northern Namoneas Project coordinator or his designee. 15 16 allottee of the funds appropriated under sections 1(4) 17 and 1(6)(b) of this act shall be the Executive Director 18 of the Chuuk State Commission on Improvement Projects. 19 At the beginning of each quarter, the Secretary of the 20 Department of Finance and Administration, or is 21 designee, shall provide a status report to the member of 22 Congress representing Chuuk Election District No. 3 on 23 the Education and Health Trust Fund created pursuant to 24 section 1(6)(b) of this act. Said report shall describe 25 the investment status of the fund and changes in fund

1 balances since the previous report, including nominal 2 and real rates of return on investments. The allottee 3 of the funds appropriated under section 1(6)(a) of this 4 act shall be the Chuuk State Commission on Improvement Projects. The allottee of the funds appropriated under 5 6 section 1(7) of this act shall be the Mayor of Polle. 7 The allottee of the funds appropriated under section 8 1(8) of this act shall be the Chuuk State Commission on 9 Improvement Projects. The allottee of the funds 10 appropriated under section 2(1) of this act shall be the respective mayor of each municipality listed therein. 11 The allottee of the funds appropriated under sections 12 2(2) through 2(8) of this act shall be the Governor of 13 14 the State of Kosrae. The allottee of the funds appropriated under section 2(9) of this act shall be the 15 16 President of the Federated States of Micronesia, or the 17 President's designee. The allottee of the funds 18 appropriated under section 3(1)(a) of this act shall be 19 the Mayor of Kolonia Town, and said allottee shall 20 obligate no more than \$3,000 of such funds for 21 administrative costs. The allottee of the funds 22 appropriated under sections 4(1) through 4(7), 4(9)through 4(18), and 4(24) of this act shall be the 23 24 Governor of the State of Yap. The allottee of the funds 25 appropriated under section 4(8) of this act shall be the

1 Speaker of the Congress of the Federated States of 2 Micronesia. The allottee of the funds appropriated 3 under section 4(23) of this act shall be the Secretary 4 of the Department of Health, Education and Social Affairs. The allottee of all other funds appropriated 5 6 by this act shall be the President of the Federated 7 States of Micronesia or the President's designee. 8 the event that the President designates the Vice 9 President as allottee, the Vice President may designate 10 a suballottee. The allottees shall be responsible for 11 ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in 12 13 this act, and that no obligations are incurred in excess 14 of the sum appropriated. The allottee of the funds appropriated under section 3(2) of this act shall 15 16 obligate no more than ten percent of such funds for 17 administrative costs.

(2) The authority of the allottee to obligate funds appropriated by this act shall not lapse."

Section 3. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
