A BILL FOR AN ACT

To further amend Public Law No. 8-24, as amended, by amending sections 2 and 3 thereof to change the use of certain funds, to change the allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

21	Section 2. Section 3 of Public Law No. 8-24, as amended by
22	Public Laws Nos. 8-56, 8-114, 9-003, 9-077, 9-145 and 10-114, is
23	hereby further amended to read as follows:
24	"Section 3. <u>Allotment and Management of Lapse date</u> .
25	(1) All funds appropriated by this act shall be

allotted, managed, administered, and accounted for in accordance with applicable law, including, but not limited to, the Financial Management Act of 1979. The allottee of the funds appropriated under subsection (1) (a) of section 2 of this act shall be the Faichuk PWP Development Authority. The allottee of the funds appropriated under subsection (1)(b) of section 2 of this act shall be the Southern Namoneas Development Authority. The allottee of the funds appropriated under subsection (1)(c) of section 2 of this act shall be the Lower Mortlocks Development Authority. [The allottee of the funds appropriated under subsection (1) (d) (i) of section 2 of this act shall be the Hall Islands Project Coordinator. The allottee of the funds appropriated under subsection (1) (d) (ii) of section 2 of this act shall be the Nomunwito Project Coordinator. The allottee of the funds appropriated under subsections (1) (d) (iii) and (1) (d) (iv) of section 2 of this act shall be the Northwest Islands Project Coordinator. The allottee of the funds appropriated under subsection (1)(d) of section 2 of this act shall be the Executive Director of the Chuuk State Commission on Improvement Projects. The allottee for all other funds appropriated under this act shall be the President of the Federated States of Micronesia or the

1	President's designee; PROVIDED, the allottee of the
2	funds appropriated under subsection (3) of section 2 of
3	this act shall be the Governor of the State of Yap.
4	The allottees shall be responsible for ensuring that
5	these funds, or so much thereof as may be necessary,
6	are used solely for the purpose specified in this act,
7	and that no obligations are incurred in excess of the
8	sum appropriated.
9	(2) The authority of the allottees to obligate funds
10	appropriated by this act shall lapse as of September
11	30, 1999."
12	Section 2. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
