A BILL FOR AN ACT

To further amend Public Law No. 7-35, as amended, by amending sections 1 and 8 thereof to change the use of certain funds, to change the allottee of certain funds, and for other purposes.

1	Section 1. Section 1 of Public Law No. $7-35$, as amended by			
2	Public Laws Nos. $7-43$, $7-68$, $8-34$ and $8-74$, is hereby further			
3	amended to read as follows:			
4	"Section 1. Statewide public projects. The sum of			
5	\$400,000, or so much thereof as may be necessary, is			
6	hereby appropriated from the General Fund of the			
7	Federated States of Micronesia for the fiscal year			
8	ending September 30, 1992, for the purpose of funding			
9	statewide public projects in the State of Chuuk. The			
10	sum appropriated by this section shall be apportioned as

The allottee of the funds 25 appropriated under section 7(3) of this act shall be the

1	School Board of the Saramen Chuuk Academy. The
2	allottees shall be responsible for ensuring that these
3	funds, or so much thereof as may be necessary, are used
4	solely for the purposes specified in this act, and that
5	no obligations are incurred in excess of the sum
6	appropriated. The authority of the allottees to
7	obligate funds appropriated by this act shall not
8	laspe."
9	Section 2. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its
11	becoming law without such approval.
