A BILL FOR AN ACT

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. 21	allotted, managed, administered, and accounted for in

23	limited to, the Financial Management Act of 1979. The
24	allottee of the funds appropriated under [subsection

the Congress of the Federated States of Micronesia. The 1 2 allottee of the funds appropriated under subsections 3 (1) (a) through (1) (j) and subsection (2) of] section 2 4 of this act shall be the Governor of Yap State. The 5 allottee $[\mathbf{s}]$ shall be responsible $[\mathbf{of}]$ for ensuring that 6 these funds, or so much thereof as may be necessary, are 7 used solely for the purposes specified in this act, and 8 that no obligations are incurred in excess of the sum 9 appropriated. 10 (2) The authority of the allottee[s] to obligate funds 11 appropriated by this act shall [not] lapse September 30, 2005." 12 Section 3.
