6	Section 2. Allotment and management of funds and lapse date.		
7	(1) All funds appropriated by this act shall be allotted,		
8	managed, administered, and accounted for in accordance with		
9	applicable law, including but not limited to the Financial		
10	Management Act of 1979. The allottee of the funds appropriated		
11	under subsections (1), (2) and (3) of section 1 of this act shall		
12	be the President of the Federated States of Micronesia. The		
13	allottee of the funds appropriated under subsection (4) of section		
14	1 of this act shall be the Chuuk State Commission on Improvement		
15	Projects, except that the funds appropriated under subsection		
16	(4)(b)(iii) of section 1 of this act shall be allotted to the		
17	Mayor of Fefan Municipality.		
18	(2) The allottees of the funds appropriated herein shall be		
19	responsible for ensuring that these funds, or so much thereof as		
20	may be necessary, are used solely for the purpose specified		
21	herein, and shall report back to the Congress on the status of		
22	these funds no later than September 30, 2005. The authority of		
23	the allottees to obligate such funds shall not lapse until fully		
24	expended.
