### PUBLIC LAW NO. 13-3

### AN ACT

To further amend Public Law No. 9-027, as amended, by amending section 5 to change the allottee for certain funds appropriated for Chuuk State Election District No. 1, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 5 of Public Law No. 9-027, as amended by Public Law No. 10-65, 12-28 and 12-42, is hereby further amended 2 to read as follows: 3 4 "Section 5. Allotment and management of funds and lapse 5 date. 6 (1) All funds appropriated by this act shall be 7 allotted, managed, administered, and accounted for in 8 accordance with applicable law, including, but not 9 limited to, the Financial Management Act of 1979. The 10 allottee of the funds appropriated under subsection (1) of section 1 of this act shall be the Director of Health 11 12 Services, Chuuk State. The allottee of the funds 13 appropriated under subsection (2) of section 1 of this 14 act shall be the Mayor of Polle Municipality. The 15 allottee of the funds appropriated under subsections (3) and (5) of section 1 of this act shall be the Chuuk 16 17 State Commission on Improvement Projects. The allottee 18 of the funds appropriated under subsection (4) of 19 section 1 of this act shall be the Northern Namoneas

2	subsection (6) of section 1 of this act shall be the
3	Pattiw Development Authority. The allottee of the funds
4	appropriated under section 2 of this act shall be the
5	Governor of Pohnpei State. The allottee of the funds
6	appropriated under section 3 of this act shall be the
7	Governor of Yap State. The allottee of the funds
8	appropriated under section 4 of this act shall be the
9	Governor of Kosrae State. The allottees shall be
10	responsible for ensuring that these funds, or so much
11	thereof as may be necessary, are used solely for the
12	purpose specified in this act, and that no obligations
13	are incurred in excess of the sum appropriated.
14	(2) All funds appropriated herein shall not lapse
15	until fully expended."
