PUBLIC LAW NO. 13-31

AN ACT

To further amend Public Law No. 10-120, as amended, by amending sections 1 and 6 thereof to change the use of certain funds appropriated for use in Chuuk State, to change the alottee of certain funds, and for other purposes.

ΒE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. Section 1 of Public Law No. 10-120, as amended by
2	Public Laws Nos. 10-122, 10-144, 11-8, 11-20, 11-32, 12-6, 12-20,
3	12-68 and 13-11, is hereby further amended to read as follows:
4	"Section 1. The sum of \$5,000,000, or so much thereof
5	as may be necessary, is hereby appropriated from the
6	General Fund of the Federated States of Micronesia for
7	the fiscal year ending September 30, 1999, for the
8	purpose of funding infrastructure and other projects and
9	programs in the State of Chuuk. The funds appropriated
10	under this section shall be apportioned as follows:
11	(1) Regional transportation projects
12	(which shall be deemed to come from capital
13	account funds available under section 211
14	of the Compact of Free Association)
15	(a) Ta airport paving and related
16	structures and equipment\$ 200,000

7	Section 2. Section 6 of Public Law No. 10-120, as amended by
8	Public Laws Nos. 10-122, 11-8, 11-10, 11-20, 11-32, 11-64, 11-75,
9	12-20, 12-47, 12-68 and 13-11, is hereby further amended to read
10	as follows:
11	"Section 6. <u>Allotment and management of funds and lapse</u>
12	<u>date</u> .
13	(1) All funds appropriated by this act shall be
14	allotted, managed, administered, and accounted for in
15	accordance with applicable law, including, but not
16	limited to, the Financial Management Act of 1979. The
17	allottee of the funds appropriated under section 1(3)(e)
18	of this act shall be the Governor of the State of Chuuk
19	or his designee. The allottee of the funds appropriated
20	under section 1(2) of this act shall be the Speaker of
21	the Congress of the Federated States of Micronesia. The
22	allottee of the funds appropriated under section 1(3)(a)
23	of this act shall be the Director of the Department of
24	Health Services. The allottee of the funds appropriated
25	under section 1(3)(c) of this act shall be the Assistant
26	Director, Land Grant Program, Cooperative Extension 4 of 8

1	Services, Chuuk State. The allottee of the funds
2	appropriated under section 1(3)(d) of this act shall be
3	the Executive Director of the Chuuk Recreation Office.
4	The allottee of the funds appropriated under section
5	1(3)(f) of this act shall be the Secretary of the
6	Department of Health, Education and Social Affairs of
7	the Federated States of Micronesia, or his designee.
8	The allottee of the funds appropriated under section
9	1(3)(g) of this act shall be the Chuuk State Commission
10	on Improvement Projects. The allottee of the funds
11	appropriated under sections $1(5)$ and $1(3)(b)$ of this act
12	shall be the Executive Director of the Northern Namoneas
13	Development Authority, or if the Northern Namoneas
14	Development Authority shall be abolished, the Northern
15	Namoneas Project Coordinator or his designee. The
16	allottee of the funds appropriated under sections 1(4)
17	and 1(6)(b) of this act shall be the Executive Director
18	of the Chuuk State Commission on Improvement Projects.
19	At the beginning of each quarter, the Secretary of the
20	Department of Finance and Administration, or his
21	designee, shall provide a status report to the member of
22	Congress representing Chuuk Election District No. 3 on
23	the Educational and Health Trust Fund created pursuant
24	to section 1(6)(b) of this act. Said report shall
25	describe the investment status of the fund and changes
26	in fund balances since the previous report, including 5 of 8

1	nominal and real rates of return on investments. The
2	allottee of the funds appropriated under section 1(6)(a)
3	of this act shall be the Chuuk State Commission on
4	Improvement Projects. The allottee of the funds
5	appropriated under section 1(7) of this act shall be the
6	Mayor of Polle. The allottee of the funds appropriated
7	under section 1(8) of this act shall be the Chuuk State
8	Commission on Improvement Projects. The allottee of the
9	funds appropriated under section 2(1) of this act shall
10	be the respective mayor of each municipality listed
11	therein. The allottee of the funds appropriated under
12	sections 2(2) through 2(8) of this act shall be the
13	Governor of the State of Kosrae. The allottee of the
14	funds appropriated under section 2(9) of this act shall
15	be the President of the Federated States of Micronesia,
16	or the President's designee. The allottee of the funds
17	appropriated under section 3(1)(a) of this act shall be
18	the Mayor of Kolonia Town, and said allottee shall
19	obligate no more than \$3,000 of such funds for
20	administrative costs. The allottee of the funds
21	appropriated under sections $4(1)$ through $4(7)$, $4(9)$
22	through $4(18)$, and $4(24)$ of this act shall be the
23	Governor of the State of Yap. The allottee of the funds
24	appropriated under section 4(8) of this act shall be the
25	Speaker of the Congress of the Federated States of
26	Micronesia. The allottee of the funds appropriated 6 of 8

1	under section 4(23) of this act shall be the Secretary
2	of the Department of Health, Education and Social
3	Affairs. The allottee of all other funds appropriated
4	by this act shall be the President of the Federated
5	States of Micronesia or the President's designee. In
6	the event that the President designates the Vice
7	President as allottee, the Vice President may designate
8	a suballottee. The allottees shall be responsible for
9	ensuring that these funds, or so much thereof as may be
10	necessary, are used solely for the purpose specified in
11	this act, and that no obligations are incurred in excess
12	of the sum appropriated. The allottee of the funds
13	appropriated under section 3(2) of this act shall
14	obligate no more than ten percent of such funds for
15	administrative costs.
16	(2) The authority of the allottees to obligate funds
17	appropriated by this act shall not lapse."

20	Section 3. This act shall become law upon approval by the
21	President of the Federated States of Micronesia or upon its
22	becoming law without such approval.
