AN ACT

To further amend Public Law No. 13-19, as amended, by amending sections 4 and 9 thereof for the purpose of making certain corrections thereto, and for other purposes. BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 4 of Public Law No. 13-19, as amended by Public Laws Nos. 13-30 and 13-35, is hereby further amended to 2 3 read as follows: "Section 4. Operating expenses of the National 4 5 Judiciary Branch. 6 The sum of \$969,071, or so much thereof as may be 7 necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal 8 9 year ending September 30, 2004, for the operations of 10 the 11 Judiciary Branch of the National Government during 12 fiscal year 2004 in order to achieve the activities set 13 forth in the performance budget pages 398 through 400 of 14 the budget book." 15 Section 2. Section 9 of Public Law No. 13-19, as amended by Public Laws Nos. 13-30 and 13-35, is hereby further amended to 16 read as follows: 17 "Section 9. Capital and Human Resource Development. 18
