PUBLIC LAW NO. 13-47

AN ACT

To amend Public Law No. 13-37 by amending section 1 thereof and by adding new sections 2 and 3 thereto to clarify the amount of funds appropriated to each of the uses identified therein, by adding a new section 4 thereto to make a supplemental appropriation of funds from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2004, by amending the existing section 3 with respect to the allottees of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 1 of Public Law No. 13-37 is hereby
- 2 amended to read as follows:
- 3 "Section 1. The sum of \$100,000, or so much thereof as
- 4 may be necessary, is hereby appropriated from the
- 5 General Fund of the Federated States of Micronesia for
- 6 the fiscal year ending September 30, 2004, for the
- 7 purpose of funding costs associated with the hosting, by
- 8 the FSM Congress, of the 2004 Asian-Pacific
- 9 Parliamentarians' Union General Assembly and Council
- 10 Meeting."
- 11 Section 2. Public Law No. 13-37 is hereby amended by adding
- 12 a new section 2 to read as follows:
- "Section 2. The sum of \$20,000, or so much thereof as may be need
- 14 purpose of funding costs associated with Congress'
- receiving of foreign visitors and dignitaries."

10	General Fund of the Federated States of Micronesia for		
11	the fiscal year ending September 30, 2004. The sum		
12	appropriated by this section shall be apportioned as		
13	follows:		
14	(1) Compensation to spouse and children of		
15	deceased quarantine officer\$ 18,000		
16	(2) Congress Special Election (Chuuk) 75,000		
17	(3) FEMA matching funds and public assistance		
18	specialist 250,000		
19	(4) FSM Mission in New York 40,000		
20	(5) Attorney fees-Udot Municipality litigation 17,502		
21	(6) Contract services (Consultants and Compact		
22	Implementation) 150,000"		
23	Section 5. Public Law No. 13-37 is hereby amended by		
24	renumbering section 3 thereof as section 5, and amending said		
25	section to read as follows:		

1	"Section 5. <u>Allotment and management of funds and lapse date</u> .		
2	(1) All funds appropriated by this act shall be		
3	allotted, managed, administered, and accounted for in		
4	accordance with applicable law, including, but not		
5	limited to, the Financial Management Act of 1979. The		
6	allottee of the funds appropriated by sections 1 and 2		
7	of this act shall be the Speaker of the Thirteenth		
8	Congress of the Federated States of Micronesia, or his		
9	designee. The allottee of the funds appropriated by		
10	sections 3 and 4 of this act shall be the President of		
11	the Federated States of Micronesia. The allottees shall		
12	be responsible for ensuring that these funds, or so much		
13	thereof as may be necessary, are used solely for the		
14	purpose specified in this act, and that no obligations		
15	are incurred in excess of the sum appropriated.		
16	(2) The authority of the allottee to obligate funds		
17	appropriated by this act shall lapse as of September 30,		
18	2005."

23	Section 6. This act shall become law upon approval by the		
24	President of the Federated States of Micronesia or upon its		

25 becoming law without such approval.
