PUBLIC LAW 13-84

AN ACT

To appropriate the sum of \$240,000 from the fund entitled "Public Projects for Chuuk Election District No. 5" within the General Fund of the Federated States of Micronesia for the purpose of funding certain public projects in Chuuk Election District No. 5, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$240,000, or so much thereof
2	as may be necessary, is hereby appropriated from the fund
3	entitled "Public Projects for Chuuk Election District No.5"
4	within the General Fund, to provide funding for public
5	projects in Chuuk Election District No. 5. The funds
6	appropriated under this section shall be apportioned as

1	(1) All funds appropriated by this act shall be
2	allotted, managed, administered, and accounted for in accordance
3	with applicable law, including but not limited to, the Financial
4	Management Act of 1979. The allottee of the funds appropriated
5	under section 1 of this act shall be the Chuuk State Commission on
6	Improvement Projects.
7	(2) The allottee of the funds appropriated herein
8	shall be responsible for ensuring that these funds, or so much
9	thereof as may be necessary, are used solely for the purpose
10	specified herein. The authority of the allottee to obligate such
11	funds shall not lapse until fully expended.
12	Section 3. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
