Urging the President to initiate negotiation on a \$40 million loan available either through the Asian Development Bank or the World Bank to establish a revolving fund for the development and rehabilitation of commercial agriculture in the FSM.

- 2 sector in the FSM economy, resulting in an increasing reliance on
- 3 imported agricultural products and a severe imbalance in the

- 6 the people of the FSM and remains a potential economic
- 7 development area for the FSM people who have access to land but
- 8 very limited access to financial capital; and
- 9 WHEREAS, the Third FSM Economic Summit held at the COM
- 10 Palikir Campus has adopted a "High Growth Scenario" Policy for
- 11 the FSM to follow in the development of its economy in response
- 12 to the tightening of financial assistance under the amended
- 13 Compact of Free Association with the United States for the next
- 14 twenty years and also the stagnant overall economic forecasts for
- 15 the FSM economy during the first decade of the New Millennium;

- WHEREAS, both the Asian Development Bank and the World Bank
- 18 have shown a commitment to extending financing to the FSM for
- 19 development of its economy and the general improvement of living
- 20 standards in the world's developing countries; now, therefore,
